# **REGULAR SESSION DECLARED AT 1:30PM**

President Palla called to order the Regular Session of the Kern Delta Board of Directors at 1:30PM.

### I. PUBLIC COMMENT

# II. CONSENT CALENDAR

M/S/C (/Bidart/Tillema) (yes-8, no-0): By roll call vote, with Director Collins absent, the Board approved and authorized items II A through II C of the Consent Calendar.

- A. Approve Minutes of the Regular Board Meeting of December 15, 2020.
- B. Approve December 2020/January 2021 District Construction and Water Banking Disbursements.
- C. Approve December 2020/January 2021 District Accounts Payable.

#### III. BUSINESS AND FINANCE

- A. <u>Business & Finance Committee January 14, 2021:</u> Controller Duncan briefly reported on the January Business & Finance Committee Meeting.
- A(i). <u>Approve December 2020 Financial Reports:</u> Mr. Duncan presented the December 2020 District and Water Banking Project Financial Statements, Treasurer's Reports, and District Delinquency Report.
- M/S/C (Antongiovanni/Tillema) (yes-8, no-0): By roll call vote, with Director Collins absent, the Board approved the December 2020 District and Water Banking Project Financial Statements, Treasurer's Reports, and Delinquency Report as presented.
- A(ii-iv). Mr. Duncan provided informational updates on three separate items: the first being an update on plans for administration and accounting for the Sunset Banking Project (a joint water banking project involving Kern Delta and Arvin Edison WSD); the second confirming a Board authorized transfer of cash assets from the KDWBP to the KDWD; and the third regarding the updated KDWD Treasurer's report reflecting the receipt of the cash transfer from the KDWBP.

# IV. OPERATIONS AND PROJECTS

- A. A(i-v). Operations and Projects Committee- January 5, 2021: Assistant General Manager Bellue briefly reported on the January Operations and Projects Committee Meeting including District maintenance activities, encroachment permit requests, the office expansion project, Branch 1 and Kern Island Basin expansion efforts, and a concept project by the City of Bakersfield to develop a multi-use path along the Kern Delta 23 Ditch. With respect to the multi-use path project concept, the Board provided staff with feedback regarding needed adjustments to the current concept.
- B. Approval of Amendment No. 1 to Agreement No. 18-067 Between Kern Delta and the City of Bakersfield (Stine Canal Ditch Eradication and Pipeline Agreement): General Manager Teglia provided a brief overview of the proposed amendment, which clarifies the obligations of the City of Bakersfield (City), so they are consistent with a separate Common Use Agreement between Kern Delta and the City for the same project. In summary the amendment requires the City to warrant, keep and maintain the pipeline portion of the Stine

Canal, associated with their TRIP project, for the life of the project. Mr. Teglia further conveyed that the City Council had recently approved the amendment.

M/S/C (Mendonca/Spitzer) (yes-8, no-0): By roll call vote, with Director Collins absent, the Board approved Amendment No. 1 to Agreement No. 18-067.

# V. KERN RIVER WATERMASTER

A. <u>District Water Master Report:</u> District Hydrographer Hyatt reviewed and discussed the water supplies of the District for the month of December and early January. Approximately 1,894 acre-feet of water was delivered in District during December. In addition, Mr. Hyatt provided graphical information regarding depth to groundwater at various monitoring locations throughout the District. Mr. Hyatt also provided information related to a long-term seasonal outlook.

B. – B(i). <u>Kern River Watermaster Report:</u> The January Kern River Watermaster Report and Isabella construction update, provided by the Army Corps of Engineers, were also highlighted by staff.

### VI. MANAGER'S REPORT

A. – A(i-ii). <u>Verbal Report:</u> Mr. Teglia provided a brief verbal report on various District activities including the release of an Initial Study/Negative Declaration (IS/ND) for the development of a Common Landowner Water Transfer Program between the Tulare Lake Basin WSD (TLBWSD) and the Kern County Water Agency (KCWA). Mr. Teglia explained that Kern Delta was one of the KCWA Member Units including in the IS/ND however, this is limited to Kern Delta receiving water from TLBWSD and the further understanding that no water will be transferred out of Kern Delta for a return to TLBWSD. This disclaimer is included in the IS/ND and is understood by the other agencies involved. Mr. Teglia also conveyed that the Kern Delta Board will have a meeting on Tuesday, February 2, 2021 to hear a presentation from a representative of Land IQ.

A(iii). <u>Approval of Resolution 2021-01 – Consent for Temporary Water Service Contract Between the United States and Kern Delta Water District (215 Water):</u> Mr. Teglia and Water Resources Manager Mulkay presented the above resolution to the Board which provides authorization for staff to enter into a temporary water service contract to obtain Section 215 water from the Central Valley Project if available.

M/S/C (Kaiser/Antongiovanni) (yes-8, no-0): By roll call vote, with Director Collins absent, the Board approved Resolution 2021-01.

- B. External Agency Report: Mr. Teglia provided verbal comments supplementing a memorandum included in the Board package which provided information on the meetings and activities of various external agencies. These agencies include, but are not limited to, the Kern County Water Agency (including the status of the Delta Conveyance Project and Contract Extension), Kern Fan Authority, Kern River Watershed Coalition Authority, Kern Groundwater Authority, Kern River Groundwater Sustainability Agency, the South Valley Water Resources Authority, the Water Association of Kern County, and the Integrated Regional Water Management Plan.
- C. <u>Water Banking Projects Report:</u> Mr. Teglia provided verbal comments supplementing a memorandum included in the Board package which provided information on water banking project activity on the Kern River Fan.
