#### **REGULAR SESSION DECLARED AT 1:21PM**

President Palla called to order the Regular Session of the Kern Delta Board of Directors at 1:21PM.

Closed Session Report: District General Counsel Iger reported the following:

#### INTRODUCTION OF GUESTS AND PUBLIC

#### I. PUBLIC COMMENT

None.

#### II. CONSENT CALENDAR

M/S/C (Mendonca/Fanucchi) (yes-9, no-0): By unanimous vote, the Board approved and authorized items II A through II C of the Consent Calendar. Item II A was approved as amended to properly reflect that the vote to approve the Land IQ Contract during the September 7, 2021 Board Meeting was 7-1-1 with Director Kaiser voting No and Director Garone Abstaining.

- A. Approval of Minutes from the Regular Board Meeting of September 7, 2021(as amended above).
- B. Approval of the August/September District Construction and Water Banking Disbursements.
- C. Approval of the August/September District Disbursements.

#### III. BUSINESS AND FINANCE

- A. <u>Business & Finance Committee September 16, 2021:</u> District Controller Duncan provided a report from the August Business & Finance Committee Meeting.
- A(i). <u>Approval of August 2021 Financial Reports:</u> Mr. Duncan presented the August 2021 District and Water Banking Project(s) Financial Statements, Treasurer's Reports, and District Delinquency Report.
- M/S/C (Antongiovanni/Tillema) (yes-9, no-0): By unanimous vote, the Board approved the August 2021 District and Water Banking Project(s) Financial Statements, Treasurer's Reports, and Delinquency Report as presented.
- B. <u>Review and Approval of 2022 District Budget:</u> Staff presented the proposed 2022 District Budget to the Board for review and approval. Staff outlined the various components of the budget and conveyed that the budget had been reviewed by the Business and Finance Committee over the course of several committee meetings. Following that process the Business and Finance Committee recommended the Board approve the budget as presented.
- M/S/C (Antongiovanni/Fanucchi) (yes-9, no-0): By unanimous vote, the Board approved the 2022 District Budget as presented and recommended by the Business and Finance Committee.
- C. Approval of Resolution 2021-06 Establishing District Assessments and Setting a Public Hearing Before the Kern Delta Board of Directors. Staff presented the Board with a resolution which establishes the District's assessments for 2022 and sets the Public Hearing before the Board for the November 16, 2021 Board meeting. It should be noted that the District's assessments have not changed from the previous year and have remained consistent since 1996.
- M/S/C (Garone/Antongiovanni) (yes-9, no-0): By unanimous vote, the Board approved Resolution 2021-06 Establishing District Assessments and Setting a Public Hearing Before the Kern Delta Board of Directors on November 16, 2021.

#### IV. OPERATIONS AND PROJECTS

- A. A(i-iii). <u>Operations and Projects Committee September 7, 2021:</u> Assistant General Manager Bellue briefly reported on the September Operations and Projects Committee Meeting including District maintenance activities, recent encroachment permit requests, and status updates related to both the Sunset Groundwater Recharge Facility project and the Old River Basins project.
- B. B(i-iii) <u>Sunset Ponds Grading Project</u>: Staff provided an update regarding the Sunset Ponds Grading Project. After the conclusion of an RFP process staff identified Wood Bros. Inc as the lowest responsive bidder and therefore is recommending awarding the Sunset Ponds Grading Project to Wood Bros. Inc in an amount not to exceed \$1,666,689.67. Staff also is recommending approving a task order with Zeiders Consulting for Construction Management Services in an amount not to exceed \$184,714. Finally, since the Sunset Grading Project is a jointly funded project between Kern Delta and Arvin-Edison WSD, staff recommends the Board authorize a transfer of \$1,000,000 to the Sunset Water Banking Project to facilitate Kern Delta's share of the above referenced construction activities. Arvin-Edison WSD will be invoiced for a like amount by the Sunset Water Banking Project.

M/S/C (Kaiser/Mendonca) (yes-9, no-0): By unanimous vote, the Board approved a contract with Wood Bros. Inc for the Sunset Ponds Grading Project (\$1,666,689.97); approved a task order with Zeiders Consulting for Construction Management Services related to the Sunset Grading Project (\$184,714); and authorized staff to transfer \$1,000,000 (\$500,000 Kern Delta/\$500,000 Water Banking Project) to the Sunset Water Banking Project.

#### V. KERN RIVER WATERMASTER

- A. A(i-ii). <u>District Water Master Report:</u> District Hydrographer Hyatt reviewed and discussed the water supplies of the District for the month of August and early September. Approximately 7,902 acre-feet of water was delivered in District during August. Mr. Hyatt also provided information related to a long-term seasonal outlook, which included current river forecast information showing a 15% April July runoff on the Kern River and the current State Water Project allocation, which is 5%. Finally, Mr. Hyatt discussed the status/schedule of various District utilities based on the current runoff information.
- B. B(i). <u>Kern River Watermaster Report:</u> The September Kern River Watermaster Report and Isabella construction update, provided by the Army Corps of Engineers, was included in the Board packet.
- C. <u>District Groundwater Manager Report:</u> Groundwater Manager Marquez provided graphical information regarding depth to groundwater at various monitoring locations throughout the District.

#### VI. MANAGER'S REPORT

- A. Mr. Teglia provided a brief verbal report. Included was a reminder that the District does not guarantee the water quality of water delivered via District canals. Staff will develop appropriate reminder language that can be included in the annual water applications and via other avenues such as the District website.
- B. External Agency Report: Mr. Teglia provided verbal comments supplementing a memorandum included in the Board package which provided information on the meetings and activities of various external agencies. These agencies include, but are not limited to, the Kern County Water Agency (including the status of the Delta Conveyance Project and Contract Extension), Kern Fan Authority, Kern River Watershed Coalition Authority, Kern Groundwater Authority, Kern River Groundwater Sustainability Agency, the South Valley Water Resources Authority, the Water Association of Kern County, and the Integrated Regional Water Management Plan.

- C. <u>Water Banking Projects Report:</u> Mr. Teglia provided verbal comments supplementing a memorandum included in the Board package which provided information on water banking project activity on the Kern Fan.
- D. <u>Legislative Update:</u> The most recent Valley Ag Water Coalition Legislative Report was included in the Board packet.

#### VII. ATTORNEY'S REPORT

A. <u>Upcoming Training:</u> Mr. Iger outlined required training for all Directors that will need to be completed prior to the end of the year. Staff will provide the Directors with an online training option that will meet the requirements of the required anti-harassment and ethics training. In addition, Mr. Iger will be providing the board with additional refresher training regarding the Brown Act and Conflict of Interest Codes at a future Board meeting.

#### **RECOMMENDATION:**

Staff recommends payment of the following fourteen payables divided into three overall groups of: 1) water banking program design, construction, and construction support -- \$00.00; 2) water banking variable -- \$265,794.11; 3) Kern Delta Water District construction -- \$00.00. The total expenditure in September for these areas is \$265,794.11 (plus additional PG&E well energy stand-by cost).

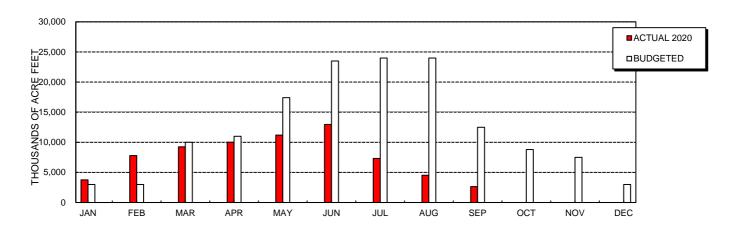

#### **INVESTMENT POLICY**

WHEREAS, the Legislature of the State of California has declared that the deposit and investment of public funds by local officials and local agencies is an issue of statewide concern (Cal. Govt. Code, §§ 53600.6 and 53630.1); and

WHEREAS, the legislative body of a local agency may invest surplus monies not required for the immediate necessities of the local agency in accordance with the provisions of California Government Code sections 5921, 16429.1, and 53601, et seq.; and

WHEREAS, the treasurer or fiscal officer of the Kern Delta Water District shall-may annually prepare and submit a statement of investment policy and such policy, and any changes thereto, shall be considered by the legislative body at a public meeting (Govt. Code, § 53646(a)).

NOW, THEREFORE, it shall be the policy of the Kern Delta Water District to invest funds in a manner which will provide the highest investment return with the maximum security while meeting the daily cash flow demands of the entity and conforming to all statutes governing the investment of Kern Delta Water District funds.

#### 1.0 SCOPE

This investment policy applies to the investment of any financial assets belonging to the Kern Delta Water District except as otherwise provided.

Funds not included in the policy may include the District's deferred compensation and employee retirement benefit funds.

#### 2.0 PRUDENCE

Investments shall be made with judgment and care, under circumstances then prevailing, which persons of prudence, discretion and intelligence exercise in the management of their own affairs; not for speculation, but for investment, considering the probable safety of their capital as well as the probable income to be derived. The standard of prudence to be used by investment officials shall be the "prudent investor" standard (Govt. Code, §53600.3) and shall be applied in the context of managing an overall portfolio. Investment officers acting in accordance with written procedures and the investment policy and exercising due diligence shall be relieved of personal responsibility for an individual security's credit risk or market price changes, provided deviations from expectations are reported in a timely fashion and appropriate action is taken to control adverse developments.

#### 3.0 **OBJECTIVES**

As specified in Government Code 53600.5, when investing, purchasing, acquiring, exchanging, selling and managing public funds, the primary objectives, in priority order, of the investment activities shall be:

- 1. <u>Safety</u>: Safety of principal is the foremost objective of the investment program. Investments of the Kern Delta Water District shall be undertaken in a manner that seeks to ensure the preservation of capital in the overall portfolio.
- 2. <u>Liquidity</u>: The investment portfolio will remain sufficiently liquid to enable the Kern Delta Water District to meet all operating requirements which might be reasonably anticipated.
- **3.** Return on Investment: The investment portfolio shall be designed with the objective of attaining a market rate of return after first obtaining safety and liquidity.

#### 4.0 DELEGATION OF AUTHORITY

Authority to manage the investment program is derived from California Government Code sections 53600, et seq. The authority to make investment decisions shall remain with the Board of Directors. Management responsibility for the investment program is hereby delegated to the Treasurer, who may establish written procedures for the operation of the investment program consistent with this investment policy. Procedures may include references to: safekeeping, PSA repurchase agreements, wire transfers, agreements, collateral/depository agreements and banking service contracts, as appropriate. Such procedures may include explicit delegation of authority to persons responsible for investment transactions. No person may engage in an investment transaction except as provided under the terms of this policy. Under the provisions of California Government Code section 53600.3, the Board of Directors and the Treasurer are trustees and fiduciaries subject to the prudent investor standard.

#### 5.0 ETHICS AND CONFLICTS OF INTEREST

Officers and employees involved in the investment process shall refrain from personal business activity that could conflict with the proper execution of the investment program, or which could impair their ability to make impartial investment decisions.

#### 6.0 AUTHORIZED FINANCIAL INSTITUTIONS AND DEALERS

The Treasurer may maintain a list of financial institutions, selected on the basis of credit worthiness, financial strength, experience and minimal capitalization authorized to provide investment services. In addition, a list may also be maintained of approved security brokers/dealers selected by credit worthiness who are authorized to provide investment and financial advisory services in the State of California. No public deposit shall be made except in a qualified public depository as established by state laws, including Government Code section 53635.

For brokers/dealers of government securities and other investments, the District shall select only broker/dealers who are licensed and in good standing with the California Department of Securities, the Securities and Exchange Commission, the National Association of Securities Dealers or other applicable self-regulatory organizations.

Before engaging in investment transactions with a broker/dealer, the Treasurer shall have received from said firm a signed Certification Form. This form shall attest that the individual responsible for the Kern Delta Water District's account with that firm has reviewed the Kern Delta Water District's Investment Policy and that the firm understands the policy and intends to present investment recommendations and transactions to the Kern Delta Water District that are appropriate under the terms and conditions of the Investment Policy.

#### 7.0 AUTHORIZED AND SUITABLE INVESTMENTS

The Kern Delta Water District is empowered by California Government Code section 53601, et seq., to invest in the following:

- A. Bonds issued by the Kern Delta Water District.
- B. United States Treasury Bills, Notes, and Bonds.
- C. Registered state warrants or treasury notes or bonds issued by the State of California.
- D. Bonds, notes, warrants, or other evidence of debt issued by a local agency within the State of California, including pooled investment accounts sponsored by the State of California, County Treasurers, other local agencies, or Joint Powers Agencies.
- E. Obligations issued by Agencies or Instrumentality of the United States Government.
- F. Bankers Acceptances with a term not to exceed 270 days. Not more than 40% of surplus funds can be invested in Bankers Acceptances and no more than 30% of surplus funds can be invested in the bankers acceptances of any single commercial bank.

- G. Prime Commercial Paper of United States corporations with assets greater than \$500 million with a term not to exceed 180 days and the highest ranking issued by Moody's Investors Service or Standard & Poor's Corp. Commercial paper cannot exceed 15% of total surplus funds, provided, that if the average maturity of all Commercial paper does not exceed 31 days, up to 30% of surplus funds can be invested Commercial paper.
- H. Negotiable Certificates of Deposit issued by federally or state chartered banks or associations. Not more than 30% of surplus funds can be invested in certificates of deposit.
- I. Repurchase/Reverse Repurchase Agreements of any securities authorized by this Section. Securities purchased under these agreements shall be no less than 102% of market value. (See special limits in Govt. Code, § 53601 (i).)
- J. Medium term notes (not to exceed 5 years) of U.S. corporations rated "A" or better by Moody's or S&P. Not more than 30% of surplus funds can be invested in medium term notes.
- K. Shares of beneficial interest issued by diversified management companies (Money Market Mutual Funds) investing in the securities and obligations authorized by this Section. Such funds must carry the highest rating of at least two of the three largest national rating agencies. Not more than 15% of surplus funds can be invested in Money Market Mutual Funds.
- L. Funds held under the terms of Trust Indenture or other contract or agreement may be invested according to the provisions of those indentures or agreements.
- M. Collateralized bank deposits with a perfected security interest in accordance with the Uniform Commercial Code (UCC) or applicable federal security regulations.
- N. Any mortgage pass-through security, collateralized mortgage obligation, mortgage-backed or other pay-through bond, equipment lease-backed certificate, consumer receivable pass-through certificate or consumer receivable-backed bond of a maximum maturity of five years. Securities in this category must be rated "AA" or better by a nationally recognized rating service. Not more than 30% of surplus funds may be invested in this category of securities.
- O. Any other investment security authorized under the provision of Government Code sections 5922, 16429.1, and 53601.
  - Also, see Government Code section 53601 for a detailed summary of the limitations and special conditions that apply to each of the above-listed investment securities. Government Code section 53601 is attached and included by reference in this investment policy.

*Prohibited Investments*. Under the provisions of Government Code sections 53601.6 and 53631.5, the Kern Delta Water District shall not invest any funds covered by this investment policy in inverse floaters, range notes, interest-only strips derived from mortgage pools or any investment that may result in a zero interest accrual if held to maturity.

#### 8.0 COLLATERALIZATION

All certificates of deposit must be collateralized by U.S. Treasury obligations. Collateral must be held by a third-party trustee and valued on a monthly basis. The percentage of collateralization on repurchase and reverse repurchase agreements will adhere to the amount required under Government Code section 53601 (i) (2).

#### 9.0 SAFEKEEPING AND CUSTODY

All securities purchased or acquired shall be delivered to the Kern Delta Water District by book entry, physical delivery, or by third-party custodial agreement as required by Government Code section 53601.

#### 10.0 DIVERSIFICATION

The Kern Delta Water District may diversify its investments by security type and institution. Assets may be diversified to eliminate the risk of loss resulting from overconcentration of assets in a specific maturity, a specific issuer, or a specific class of securities.

#### 11.0 REPORTING

In accordance with Government Code section 53646 (b) (1), the Treasurer shall submit to the Board of Directors a quarterly investment report. The report shall include a complete description of the portfolio, the type of investments, the issuers, maturity dates, par values and the current market values of each component of the portfolio, including a description of funds managed for Kern Delta Water District by third-party contracted managers. The report will also include the source of the portfolio valuation. As specified in Government Code section 53646 (e), if all funds are placed in LAIF, FDIC-insured accounts and/or in a county investment pool, the foregoing report elements may be replaced by copies of the latest statements from such institutions. The report must also include a statement that (1) all investment actions executed since the last report have been made in full compliance with the investment policy or the manner in which the

investment portfolio is not in compliance with the policy and, (2) the Kern Delta Water District will meet its expenditure obligations for the next six months or why sufficient funds may not be available, as required by Government Code section 53646 (b) (2) and (3) respectively. The Treasurer shall maintain a complete and timely record of all investment transactions.

#### 2. <u>ASSISTANT GENERAL MANAGER'S REPORT:</u>

- a. Approve minutes of the Operations and Projects Committee Meeting of September 7, 2021: M/S/C (Spitzer/Mendonca) (yes-3, no-0): The Committee approved the minutes of the Operations and Projects Committee meeting held on September 7, 2021.
- b. Encroachment Permit Update: Mr. Bellue presented three encroachment requests, the first from PG&E to install a new overhead electrical crossing on the Central Branch at Panama Lane. A request from Summit Capital Ventures, also on the Central Branch Canal at Panama Lane, to install a fence between the canal and a housing tract. The last request was from Griffith Company for the installation of a multi-use path for the City of Bakersfield adjacent to the 23 Ditch.
- c. <u>District Facility and Banking Maintenance</u>: Mr. Bellue discussed several items of note including replacing a rusted crossing on the Eastside Canal at Stenderup Avenue and the removal of a diversion wall and waterman gate inside the East Branch Canal standpipe at Casa Loma Drive to improve flow. Also mentioned, was the ongoing efforts to excavate and stockpile concrete irrigation pipe at the Old River Basins property.
- d. Water Banking Construction and Power Invoices: M/S/C (Mendonca/Kaiser) (yes-3, no-0): The Committee recommended the Board approve payment of Water Banking and Power Invoices totaling \$265,794.11 (plus additional PG&E well energy costs). #### **RECITALS**:

WHEREAS, District is the owner and operator of an irrigation canal commonly known as the CENTRAL BRANCH CANAL ("Canal") that currently crosses under the Citymaintained road, known as Panama Lane, in a pipe culvert ("Area of Common Use").

**WHEREAS**, the Area of Common Use is owned by Applicant and subject to an easement by District for canal purposes which predates City's easement of right of way as shown in the map attached and incorporated into this Agreement as Exhibit A; and

WHEREAS, Applicant is constructing a project in the Area of Common Use, and because of the project, Applicant must widen and improve Panama Lane, which requires an extension of the currently existing pipe culvert as explained in detail in Approved Plans as defined below (the "Facilities"); and

**WHEREAS,** District is willing to consent to the construction of the Facilities in the Area of Common Use on the conditions identified below.

#### **AGREEMENT**:

NOW, THEREFORE, FOR GOOD AND VALUABLE CONSIDERATION, IT IS AGREED AS FOLLOWS:

#### 1. Construction of Facilities:

- a. Applicant has prepared, at its expense, detailed plans and specifications (including bid and contract documents) for the construction of Facilities in the Area of Common Use which have been approved by the District and City (the "Approved Plans"). While not attached as an exhibit, the Approved Plans are incorporated herein and made a part hereof.
- b. Applicant agrees to construct and install the Facilities in strict compliance with the Approved Plans. In no event shall Applicant install additional or different facilities without first obtaining the written approval of District and City.
- c. Applicant agrees to construct and install the Facilities within the Area of Common Use easement to the depth and on the grade as set forth in the Approved Plans and in the

manner designated and approved in writing by District's engineer. In all instances, said construction and installation work shall be done at a time that will not interfere with the flow or distribution of water through the Canal as required and approved by District in writing, unless that requirement is waived by the District in writing, or interfere with the use of Panama Lane, except as approved by City in writing. Applicant acknowledges and agrees that work on said project can commence on the assigned date for commencement approved by the District and City in writing (the "Commencement Date"). Once the Canal is shut down, failure to complete the project by the assigned date for completion approved by the District in writing (the "Completion Date") will result in liquidated damages of \$3,000.00 per day for every day the Canal is shut down or the project remains incomplete beyond the assigned Completion Date unless District grants an extension to Applicant in writing. Applicant agrees to furnish District a performance bond in the amount of \$191,390.00 payable to District should Applicant fail to complete the Facilities as approved.

- d. Applicant shall pay the entire cost of laying, constructing and installing the Facilities including the costs of all labor and materials incurred or used in connection with the installation, trenching, backfilling, leveling and testing of the same, and the cost of all engineering, professional and other necessary services furnished by District, City, or others in connection therewith. In addition, District and City may hire at Applicant's expense a construction inspector to inspect the work performed by Applicant. Applicant shall provide District and City copies of all as-built drawings depicting the location of the Facilities as constructed.
- e. In the event Applicant does not pay the entire cost as described in Section 1.d and complete said work as provided in this Agreement, District or City may, but shall not be required to, pay such costs and complete such work, and Applicant does hereby agree to repay District or City, as the case may be, any amount so expended together with interest thereon at ten percent (10%) per annum from the date the same is expended until the date of repayment. In the event District or City is required to complete said work as provided in this Agreement, Applicant acknowledges and agrees that Applicant shall still be subject to and liable for the liquidated damages specified herein until District or City completes said work.
- f. Applicant agrees that, upon completion of construction and installation of Facilities to the satisfaction of the District and City, the Facilities shall become and remain the property of City. District shall be in sole and absolute control of the manner, method, and time of conducting and discharging water through Facilities.

#### 2. <u>Construction of Project</u>

- a. District and City hereby consent to the construction, operation, maintenance and use of the Facilities in the Area of Common Use subject to the terms and conditions herein contained.
- b. Applicant and City acknowledge District's Easement and the priority of District's title over Applicant's rights in the Area of Common Use. Except as expressly set forth

herein, this Agreement shall not in any way alter, modify, or terminate the legal rights of District in District's Easement or the Canal or the rights of City in City's Easement or the Road.

- c. District has and reserves the right to use the Area of Common Use for all of the purposes for which District's Easement was acquired, without need for any further permit or permission from Applicant. City has and reserves the right to use the Area of Common Use for all the purposes for which City's Easement was acquired not inconsistent with District's use. Applicant and City shall use the Area of Common Use in such a manner as to not unreasonably interfere with District's right to use Canal for any and all lawful purposes. Applicant and District shall use the Area of Common Use in such a manner as to not unreasonably interfere with City's right to use Road for any and all lawful purposes.
- d. Any construction work in the Area of Common Use shall be done at a time that will not interfere with the flow or distribution of water through the Canal as required and approved by District and not unreasonably interfere with the Project or interfere with the use of the Road as required and approved by City.

#### 3. <u>Maintenance of the Area of Common Use.</u>

- a. City shall maintain Panama Lane and the Facilities in the Area of Common Use in good condition and repair and shall pay all costs of such repairs and maintenance and of any replacement of any part thereof required to provide safe access to the Area of Common Use. City shall coordinate the timing of any maintenance activities to ensure there is no interruption to the flow of the Canal.
- b. In the event City fails, neglects, or refuses to repair, maintain, or promptly replace any of the Facilities that are in such a state of disrepair as to cause interruptions to District's operations, District shall have the right to remove any or all of the Facilities.

#### 4. <u>Miscellaneous</u>:

a. By entering into this agreement District does not extinguish, abandon, forfeit, relinquish, waive, modify, limit, restrict, or alter in any way District's water rights, including but not limited to, any and all water rights associated with or conveyed across the Area of Common Use, and this agreement further does not and will not restrict, interrupt, limit, or diminish District's use of and access to any of this water rights and water supplies.

#### b. Indemnity:

i. For Benefit of District. Applicant hereby agrees and undertakes to indemnify, defend and hold harmless District, its officers, agents, and employees from any and all losses, costs, expenses (including reasonable attorneys' fees), claims, liabilities,

actions or damages of any nature whatsoever, including injuries to or the death of any person or persons or damage to any property, in any way arising out of or connected with or incident to or alleged to have arisen in any manner out of, or to have been in any way connected with or incident to any negligent, reckless, or willful act or omission of Applicant, its officers, agents, employees, contractors, subcontractors, or independent contractors in the performance of this Agreement or to have occurred as a result of any, negligent, reckless, or willful acts or omissions by Applicant, its officers, agents, and employees in the performance of this Agreement.

- ii. For Benefit of City. Applicant hereby agrees and undertakes to indemnify, defend and hold harmless City, its officers, agents, and employees from any and all losses, costs, expenses (including reasonable attorneys' fees), claims, liabilities, actions or damages of any nature whatsoever, including injuries to or the death of any person or persons or damage to any property, in any way arising out of or connected with or incident to or alleged to have arisen in any manner out of, or to have been in any way connected with or incident to any negligent, reckless, or willful act or omission of Applicant, its officers, agents, employees, contractors, subcontractors, or independent contractors in the performance of this Agreement or to have occurred as a result of any negligent, reckless, or willful acts or omissions by Applicant, its officers, agents, and employees in the performance of this Agreement.
- c. Any contractor working in the Area of Common Use shall procure and maintain general liability insurance, providing coverage on an occurrence basis for bodily injury, including death, of one or more persons, property damage and personal injury, with limits of not less than One Million Dollars (\$1,000,000.00) per occurrence. The liability policy shall contain an additional insured endorsement which shall expressly name the District, the City, their officers, agents, servants, employees and consultants as additional insureds, without limitation. In addition, the contractor and/or subcontractors shall maintain workers' compensation insurance while working within the Area of Common Use. The workers' compensation policy shall contain an express waiver of subrogation endorsement in favor of the District, the City, their officers, agents, servants, employees and consultants. Said additional insured endorsement and workers' compensation subrogation endorsement shall be furnished in the form approved by the District's and City's legal counsel prior to any work authorized pursuant to this Agreement.
- d. District, City, and Applicant shall not become or be deemed partners or joint venturers or associates by reason of the provisions of this Agreement. No Party shall for any purpose be considered an agent, officer or employee of the other Party.
- e. The failure of any Party to enforce against another Party any provision of this Agreement shall not constitute a waiver of that Party's right to enforce such a provision at a later time and shall not serve to vary the terms of this Agreement.
- f. This Agreement may be modified only in writing approved by District, City, and Applicant and signed by all the Parties.

## **Location & Description**

Isabella Lake Dam (consisting of a Main Dam, Auxiliary Dam and service spillway) is located about 40 miles northeast of Bakersfield in Kern County, California, and became fully operational in 1953. The Main Dam is located near the confluence of the north and south forks of the Kern River and the Auxiliary Dam is located about half a mile east of the Main Dam. The Main Dam is a 185-foot-high earth-fill dam, and the Auxiliary Dam is a 100-foot-high earth-fill dam. The service spillway is located between the two dams. The reservoir (Isabella Lake) has a gross storage capacity of 568,075 acre feet.

# **Advisory**

- USACE has established enhanced protocols to ensure the safety
  of our employees and our partners, and to take necessary precaution to prevent the spread of COVID-19.
- The Phase II Dams and Spillways contractor continues construction activities. As a result, the site including Engineers Point is an active construction area and is off limits to the public.
- Corps policy prohibits public operation of unmanned aircraft systems, such as drones, on or above federal lands and waters managed by USACE. The policy is intended to ensure critical infrastructure security and public safety.

# Looking Ahead Next 30+ days)

- Excavation and slope stabilization continues on the Emergency Spillway at 63% complete. Steel rebar, slab and wall placement work also continues on the Labyrinth Weir at 69% complete.
- The Auxiliary Dam embankment is now at new crest elevation 2653.
- The Main Dam Emergency Action Plan is scheduled to be complete at the end of the month (Main Dam work pictured above).
- A property appraisal for the U.S. Forest Service Visitor Center proposed site is complete and next steps for real estate actions are in evaluation.
- Final design for the Permanent Operations Building is scheduled to be complete in November.
- USACE will provide updates on any changes via public outreach, the monthly SITREP, and the Isabella Task Force engagements.

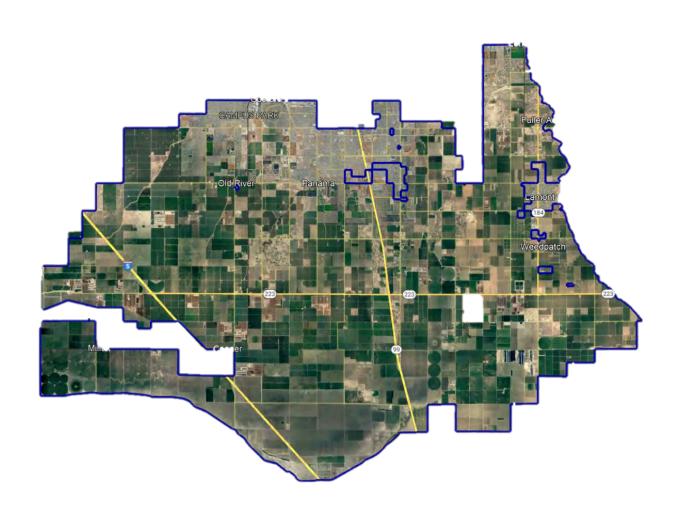
The current pool resides at 51,151 acre-feet (elevation 2,532 feet-IPD), which is 14% of restricted pool.

As part of our interim risk reduction measures, Isabella Lake is restricted to 361,250 acre-feet (elevation 2,585.5 feet-IPD) outside of flood season. # Kern Fan Recovery Activity:

- As of October 12, 2021, Kern Fan groundwater recovery was approximately 683cfs from 174 wells, as reported via KCWA weekly call.

- Next meeting scheduled for January 19, 2022.

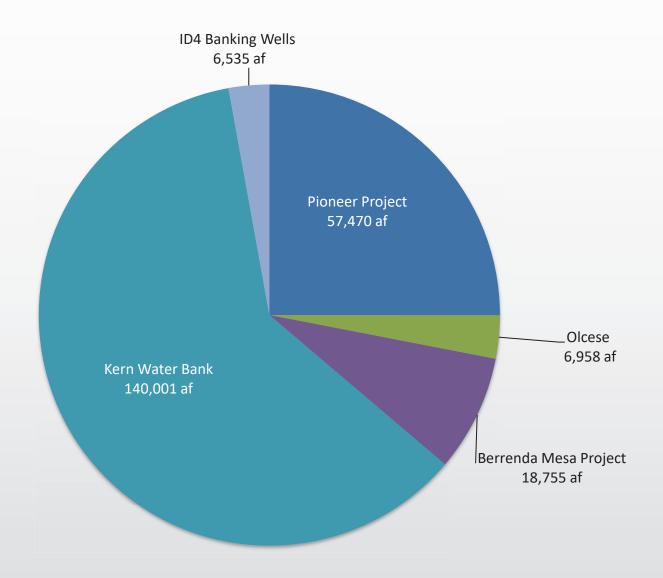
# KDWD Water Banking Project:

- MET has provided the District with an official request for the return of regulated water for calendar year 2021. The District has developed and implemented a plan to return just over 40,000af of return water to MET by December 31, 2021.
- Reduced Kern River flow has impacted the original plan for returned water to MET. Return water will likely be closer to 28,000+af.
- SBVMWD has withdrawn their request for return water in 2021.
- Currently all District wells are off.
- MET has provided the District with an official request for the return of regulated water for calendar year 2022. The District is currently developing a plan to facilitate recovery and return to MET.

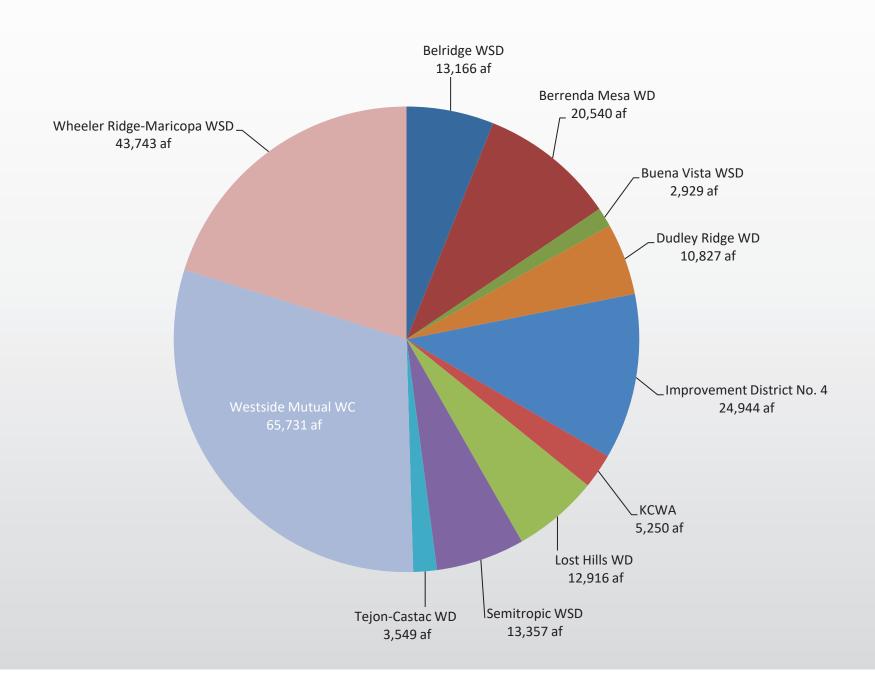

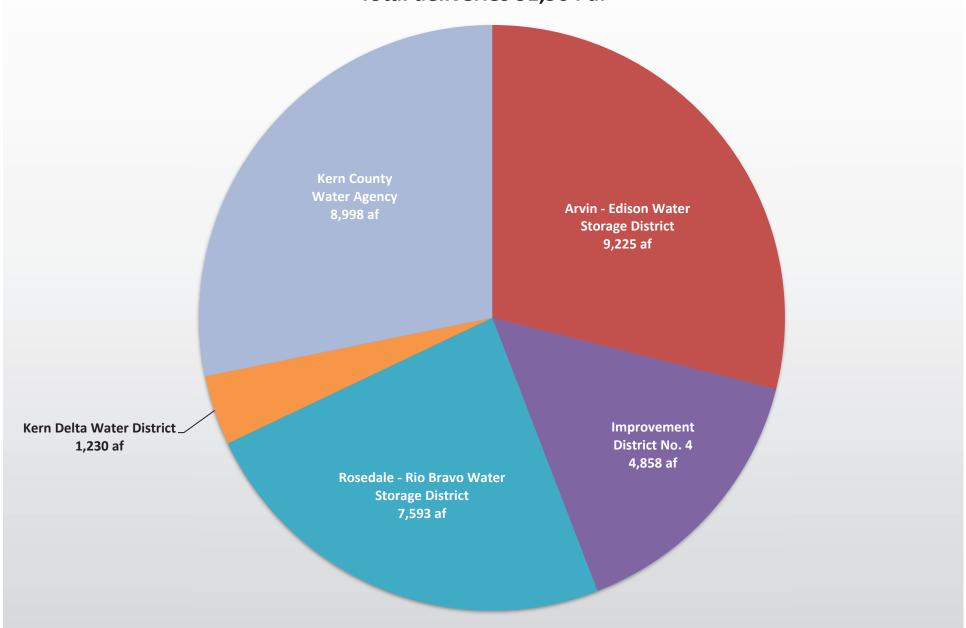
# Kern Fan Banking Projects 2021 Estimated Gross Recovery by Project Through August 31, 2021



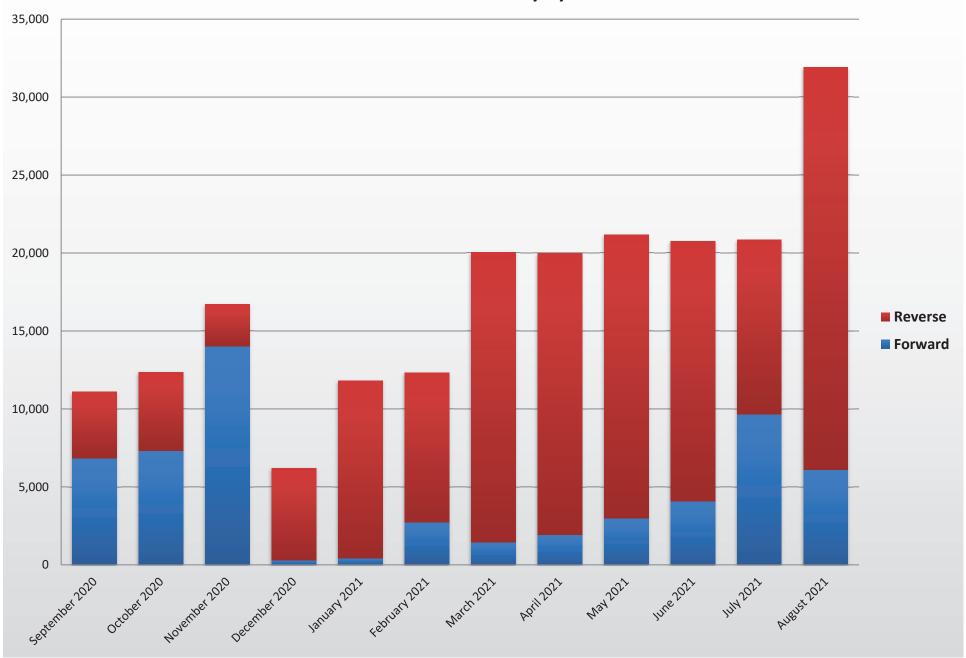
# Kern Fan Banking Projects 2021 Estimated Recovery by Participant Through August 31, 2021



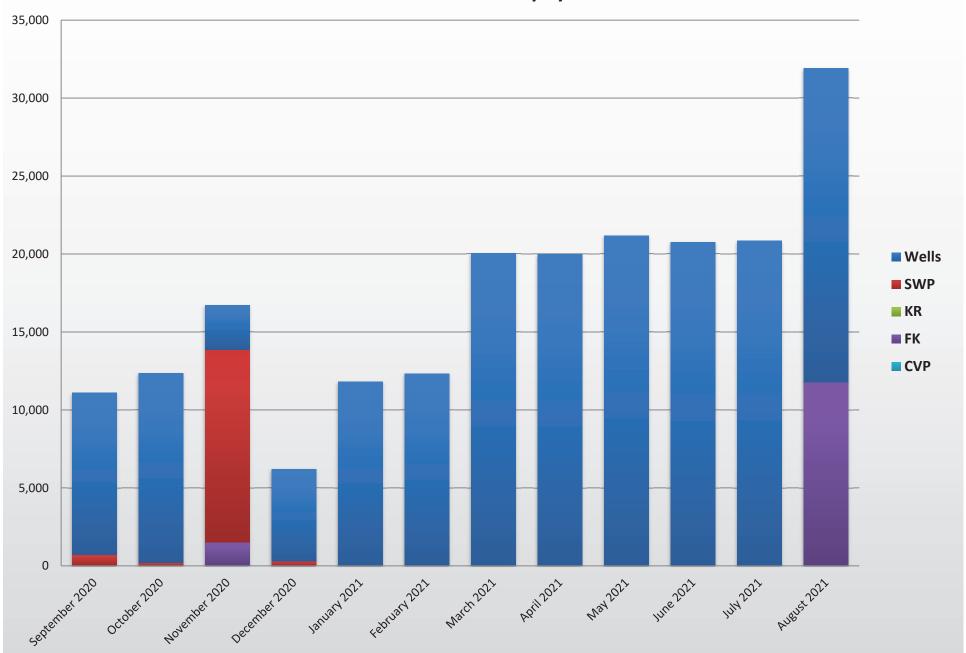

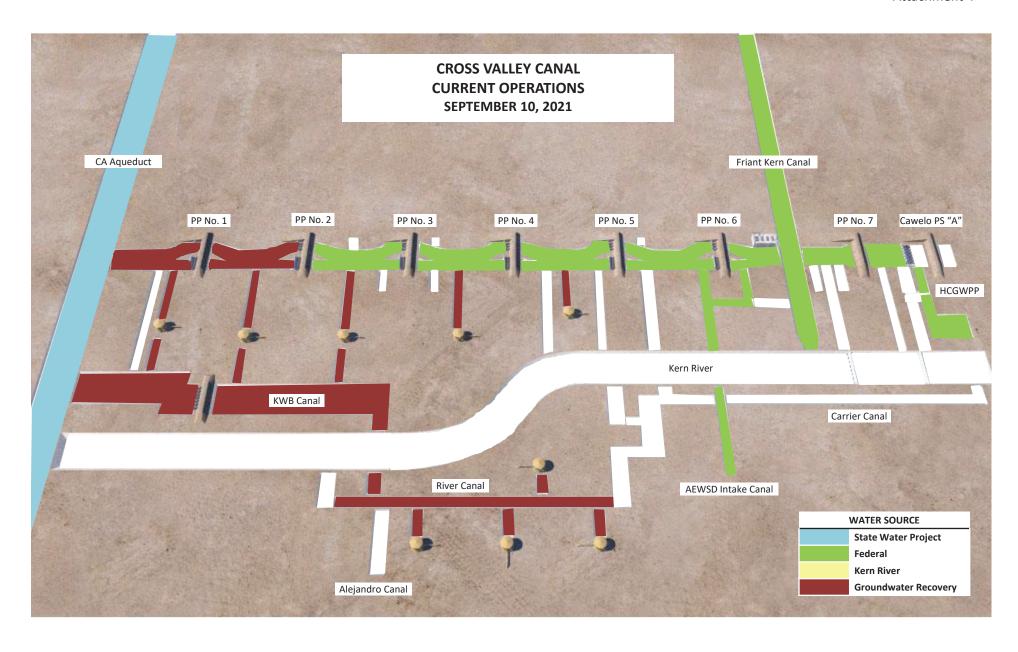


# **Cross Valley Canal Twelve Month Delivery by Direction**

The bill would create the Waterway Recovery Account in the Waste Discharge Permit Fund and would make moneys in the Waterway Recovery Account available for the state board to expend, upon appropriation by the Legislature, to bring impaired water segments into attainment in accordance with the plan.

The act authorizes the board to adopt an interim plan for a probationary basin, as specified. This bill would authorize the department to extend the deadline for a high- or medium-priority basin not subject to critical conditions of overdraft to be managed under a groundwater sustainability plan or coordinated plans by up to 180 days after January 31, 2022, upon request of a local agency or groundwater sustainability agency in the basin for an extension of a specified period of time. The bill would require a request to be submitted by January 3, 2022, and to be responded to by the department by January 10, 2022.

This bill would specify that the exclusion from being considered a dam for a barrier that is not across a stream channel, watercourse, or natural drainage area and that has the principal purpose of impounding water for agricultural use applies only to a barrier owned or operated by a private entity. The bill would provide that a barrier owned or operated by a public entity that is not across a stream channel, watercourse, or natural drainage area and that has the principal purpose of impounding water for agricultural use shall not be considered a dam only if certain criteria are met, including, among other criteria, that the operator provides to the county office of emergency management a structural failure plan.

This bill would require the state board to make the certificate or statement available on its internet website for a 60-day public comment and review period, and would provide that the certificate or statement shall not be final until voted upon by a majority of the members of the state board at the conclusion of that period.
