President Palla called to order the Regular Session of the Kern Delta Board of Directors at 12:12PM.

M/S/C (Antongiovanni/Mendonca) (yes-9, no-0): By unanimous vote the Board approved the minutes as presented from the regular board meeting of September 20, 2022.

B (i and ii). Old River Water Banking Project: Mr. Bellue discussed the proposed final design of the Old River Water Banking project and showed the Board an overview of the project. President Palla inquired about the possibility of delivering water directly to Pond 3 via the low flow channel. Mr. Bellue stated that it could be done with a simple adjustment to the design. The Board had a few other discussion items for staff to research before moving forward but did not want to slow down the bidding process.

- ii. Authorization for Staff to Solicit Bids for Construction of the Old River Water Banking Project

M/S/C (Spitzer/Mendonca) (yes-9, no-0): By unanimous vote the Board approved items B(i) and (ii) above with the slight change to accommodate delivery of water directly into Pond 3.

C. <u>District Investment Review and Discussion:</u> Mr. Duncan and Director Antongiovanni discussed possible investment opportunities for the District including CDs, Treasury Bills, and Treasury Bonds. The Board contemplated several different scenarios regarding the desired amount to invest and the duration of those investments. The consensus was that the Business and Finance Committee should be given the authority to review potential investments and decide on the initial investment at their next meeting. The Board would also like the Business and Finance Committee to continue to review available investments and develop a plan to invest more money.

M/S/C (Tillema/Garone) (yes-9, no-0): By unanimous vote the Board gave the Business and Finance Committee the authority to invest up to six million dollars in accordance with District's Investment Policy at their next meeting.

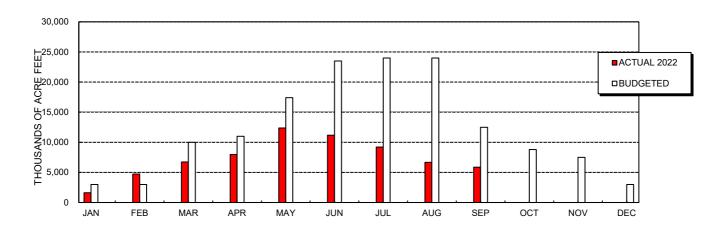

RECOMMENDATION:

Receive report.

DISCUSSION:

The Investment Policy of Kern Delta Water District requires the District's Treasurer to submit to the Board of Directors a quarterly investment report. In compliance with this directive the District Controller offers the discussion and analysis of the District's cash and investments position and performance through the third quarter of the current year as of September 30, 2022

As of September 30, 2022, the investment portfolio of the District and the District's Water Banking Programs consisted of deposits held by the Kern County Treasury in the amount of \$20,672,173; \$6,432,683; and \$1 respectively for a total investment of \$27,104,857. As of June 30, 2022 (the most recent date of calculation), these funds earned interest at an annualized rate of 0.999% compared to 0.950% as of March 31, 2021. The attached "Kern County Treasurer's Pooled Cash Portfolio Summary" describes the nature and mix of the investments managed by the Kern County Treasury for participants, including the District and the Banking Programs, in the County's Pooled Cash Portfolio.

As of September 30, 2022, the portfolio's Fair Market Value had risen slightly to 96.88% of Original Cost compared to 96.77% reported as of June 30, 2022. Note the FMV of U.S. Treasuries is 95.45% of Cost and is an improvement from the 5.01% reported last quarter. As U.S. Treasuries represent 42% of the entire portfolio (compared to 41% three months ago), the performance of these instruments is a key factor in the overall valuation of the portfolio. As has been noted in past reviews, the FMV adjustment is a valuation disclosure required by generally accepted accounting principles and does not reflect the purchasing power of the investment. If all invested cash was liquidated from the District's accounts at Kern County, the actual cost, plus accrued interest, would be recovered and not the fair market value.

On October 4, 2022, the Board of Directors, noting the favorable increase in yields available in the secure fixed income investments market, directed the Business & Finance Committee and District Staff to invest District funds in the amount of \$6 million held at the Kern County Treasury in Policy-approved secure fixed income instruments. On October 6, 2022, the Business & Finance Committee authorized the

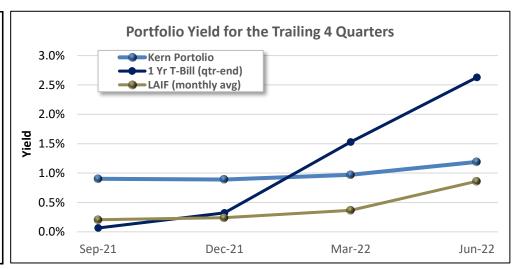
investment of \$3 million for a period of one year in U.S. Treasury Bills and an additional \$3 million for a period of two years in U.S. Treasury Notes.					

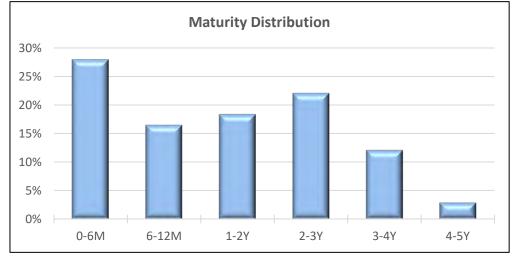


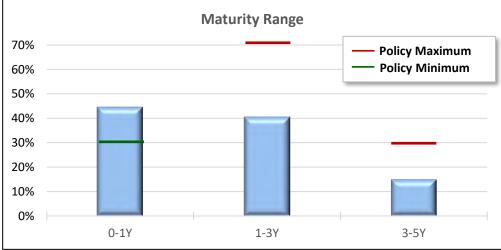

THREE PARTY COMMON USE AGREEMENT

THIS AGREEMENT is made on DELTA WATER DISTRICT, a California water dis STORES OF CALIFORNIA, ("Applicant"), and the District, Applicant, and City are sometimes hereinafter in or the "Parties".	strict ("District"), LOVE'S COUNTRY e CITY OF BAKERSFIELD ("City").

RECITALS:

WHEREAS, Applicant is under contract to acquire certain real property in the City of Bakersfield, County of Kern, State of California, commonly referred to as Assessor Parcel Nos. 517-030-08 and 517-030-06 (the "Applicant Property").

WHEREAS, District is the owner and operator of an irrigation canal commonly known as the **Kern Island Canal** ("Canal") now existing as an open ditch and is the owner of an easement and right-of-way over and across a portion of the Applicant Property.

WHEREAS, upon Applicant's acquisition of the Applicant Property, Applicant desires to extend the existing box culvert on the Canal at Taft Highway ("Facilities") within City's street right of way ("Area of Common Use") as shown in Exhibit "A" to substitute the existing open ditch; and

WHEREAS, the Facilities will be within City's road right-of-way, and City acknowledges that Facilities and Canal will maintain the "first in time" priority over City's road right-of-way; and

WHEREAS, District is willing to consent to the construction of the Facilities in the Area of Common Use on the conditions identified below.

AGREEMENT:

NOW, THEREFORE, FOR GOOD AND VALUABLE CONSIDERATION, IT IS AGREED AS FOLLOWS:

1. Construction of Facilities:

a. Notwithstanding anything to the contrary in this Agreement, Applicant's (i) acquisition of the Applicant Property, and (ii) receipt of all governmental permits and approvals, are conditions precedent to Applicant's obligations under this Agreement including, without limitation, the obligation to construct the Facilities.

- b. Applicant has prepared, at its expense, detailed plans and specifications (including bid and contract documents) for the construction of Facilities to be installed within the Area of Common Use which have been approved in writing by the District and City (the "Approved Plans"). While not attached as an exhibit, the Approved Plans are incorporated herein and made a part hereof.
- c. Applicant agrees to construct and install the Facilities in strict compliance with the Approved Plans. In no event shall Applicant install additional or different facilities without first obtaining the written approval of District and City. In all instances, said construction and installation work shall be done at a time that will not interfere with the flow or distribution of water through the Canal as required and approved by District in writing, unless that requirement is waived by the District in writing. Applicant acknowledges and agrees that work on the Facilities can commence on the assigned date for commencement approved by the District and City in writing (the "Commencement Date"). Once the Canal is shut down, failure to complete work on the Facilities by the assigned date for completion approved by the District in writing (the "Completion Date") will result in liquidated damages of \$10,000.00 per day for every day the Canal is shut down or interferes with the flow or distribution of water through the Canal beyond the assigned Completion Date unless District grants an extension to Applicant in writing. Applicant agrees to furnish District a cash deposit or performance bond in the amount of \$556,714 payable to District should Applicant fail to complete the Facilities as required by this Agreement.
- d. Applicant shall pay the entire cost of laying, constructing and installing the Facilities including the costs of all labor and materials incurred or used in connection with the installation, trenching, backfilling, leveling and testing of the same, and the cost of all engineering, professional and other necessary services furnished by District, City, or others in connection therewith. In addition, either District or City may hire at Applicant's expense a construction inspector to inspect the work performed by Applicant. Applicant shall provide District and City copies of all as-built drawings depicting the location of the Facilities as constructed.
- e. In the event Applicant does not pay the entire cost as described in Section 1.d and complete said work as provided in this Agreement, District or City may, but shall not be required to, pay such costs and complete such work, and Applicant does hereby agree to repay District or City, as the case may be, any amount so expended together with interest thereon at ten percent (10%) per annum from the date the same is expended until the date of repayment. In the event District or City is required to complete said work as provided in this Agreement, Applicant acknowledges and agrees that Applicant shall still be subject to and liable for the liquidated damages specified herein until District or City completes said work. In the event Applicant enters into any agreement with the City or any other third party related to reimbursement for all or any portion of the cost of the Facilities (a "Reimbursement Agreement"), (i) Applicant's obligations under Section 1.d, above, and this Section 1.e are expressly subject to the terms thereof, and shall not limit or otherwise affect Applicant's right to reimbursement under such Reimbursement Agreement, if any, except as expressly stated therein; and (ii) as between Applicant, the City, and any third party, such Reimbursement Agreement, if any, shall control over the terms of this Agreement.

f. Applicant agrees that, upon completion of construction and installation of Facilities to the satisfaction of the District and City, the Facilities shall become and remain the property of City. District shall be in sole and absolute control of the manner, method, and time of conducting and discharging water through Facilities.

2. <u>Common Use and Priority</u>

- a. District and City hereby consent to the construction, operation, maintenance and use of the Facilities in the Area of Common Use subject to the terms and conditions herein contained.
- b. Applicant and City acknowledge District's Easement and the priority of District's title over Applicant's rights in the Area of Common Use. Except as expressly set forth herein, this Agreement shall not in any way alter, modify, or terminate the legal rights of District in District's Easement or the Canal or the rights of City in City's Easement or the Road.
- c. District has and reserves the right to use the Area of Common Use for all of the purposes for which District's Easement was acquired, without need for any further permit or permission from Applicant and/or City. Nothwithstanding, in order to maintain public safety and to avoid future liability, District will notify City when it intends to construct in the Area of Common Use and City will issue a no fee permit to District. City has and reserves the right to use the Area of Common Use for all the purposes for which City's Easement was acquired not inconsistent with District's use. Applicant and City shall use the Area of Common Use in such a manner as to not unreasonably interfere with District's right to use Canal for any and all lawful purposes. Applicant and District shall use the Area of Common Use in such a manner as to not unreasonably interfere with City's right to use Road for any and all lawful purposes.
- d. Any construction work in the Area of Common Use shall be done at a time that will not interfere with the flow or distribution of water through the Canal as required and approved by District and not unreasonably interfere with the Facilities or interfere with the use of the road as required and approved by City.

3. Maintenance of the Area of Common Use.

- a. City shall maintain the Facilities in good condition and repair and shall pay all costs of such repairs and maintenance and of any replacement of any part thereof required to provide safe access to the Area of Common Use. City shall coordinate the timing of any maintenance activities to ensure there is no interruption to the flow of the Canal.
- b. In the event City fails, neglects, or refuses to repair, maintain, or promptly replace any portion of the Facilities that is in such a state of disrepair as to cause interruptions to District's operations, District shall provide City with written notice of the situation with a timeframe for when repairs need to be completed. If City fails to make the necessary repairs within a time provided in the letter, District shall have the right to make the necessary repairs to the Facilities and will bring it back up to grade. City will be responsible for paving the street.

4. Miscellaneous:

a. By entering into this agreement District does not extinguish, abandon, forfeit, relinquish, waive, modify, limit, restrict, or alter in any way District's water rights, including but not limited to, any and all water rights associated with or conveyed across the Area of Common Use, and this agreement further does not and will not restrict, interrupt, limit, or diminish District's use of and access to any of this water rights and water supplies.

b. Indemnity:

- i. For Benefit of District. Applicant hereby agrees and undertakes to indemnify, defend and hold harmless District, its officers, agents, and employees from any and all losses, costs, expenses (including reasonable attorneys' fees), claims, liabilities, actions or damages of any nature whatsoever, including injuries to or the death of any person or persons or damage to any property, in any way arising out of or connected with or incident to or alleged to have arisen in any manner out of, or to have been in any way connected with or incident to any negligent or reckless act or omission or willful misconduct of Applicant, its officers, agents, employees, contractors, subcontractors, or independent contractors in the performance of this Agreement or to have occurred as a result of any, negligent or reckless acts or omissions or willful misconduct by Applicant, its officers, agents, and employees in the performance of this Agreement.
- ii. For Benefit of City. Applicant hereby agrees and undertakes to indemnify, defend and hold harmless City, its officers, agents, and employees from any and all losses, costs, expenses (including reasonable attorneys' fees), claims, liabilities, actions or damages of any nature whatsoever, including injuries to or the death of any person or persons or damage to any property, in any way arising out of or connected with or incident to or alleged to have arisen in any manner out of, or to have been in any way connected with or incident to any negligent or reckless act or omission or willful misconduct of Applicant, its officers, agents, employees, contractors, subcontractors, or independent contractors in the performance of this Agreement or to have occurred as a result of any negligent or reckless acts or omissions or willful misconduct by Applicant, its officers, agents, and employees in the performance of this Agreement.
- c. Any contractor working in the Area of Common Use shall procure and maintain general liability insurance, providing coverage on an occurrence basis for bodily injury, including death, of one or more persons, property damage and personal injury, with limits of not less than One Million Dollars (\$1,000,000.00) per occurrence. The liability policy shall contain an additional insured endorsement which shall expressly name the District, the City, their officers, agents, servants, employees and consultants as additional insureds, without limitation. In addition, the contractor and/or subcontractors shall maintain workers' compensation insurance while working within the Area of Common Use. The workers' compensation policy shall contain an express waiver of subrogation endorsement in favor of the District, the City, their officers, agents, servants, employees and consultants. Said additional insured endorsement and workers'

compensation subrogation endorsement shall be furnished in the form approved by the District's and City's legal counsel prior to any work authorized pursuant to this Agreement.

- d. District, City, and Applicant shall not become or be deemed partners or joint venturers or associates by reason of the provisions of this Agreement. No Party shall for any purpose be considered an agent, officer or employee of the other Party.
- e. The failure of any Party to enforce against another Party any provision of this Agreement shall not constitute a waiver of that Party's right to enforce such a provision at a later time and shall not serve to vary the terms of this Agreement.
- f. This Agreement may be modified only in writing approved by District, City, and Applicant and signed by all the Parties.
- g. In the event of a conflict between the terms, conditions or specifications set forth in this Agreement and those in exhibits attached hereto, the terms, conditions or specifications set forth in this Agreement shall prevail. All exhibits to which reference is made in this Agreement are deemed incorporated in this Agreement whether or not actually attached.
- h. All notices relative to this Agreement shall be given in writing and shall be personally served or sent by certified or registered mail and be effective upon actual personal service or depositing in the United States mail. The Parties shall be addressed as follows, or at any other address designated by notice:

- k. The rights and obligations of this Agreement shall inure to the benefit of, and be binding upon, the Parties to this Agreement and their heirs, administrators, executors, personal representatives, successors and assigns.
- 1. Each individual signing this Agreement on behalf of the respective entities represents and warrants that he or she is, respectively, duly authorized to sign on behalf of the entities and to bind the entities fully to each and all of the obligations set forth in this Agreement.
- m. Each Party shall execute and deliver such papers, documents, and instruments, and perform such acts as are necessary or appropriate, to implement the terms of this Agreement and the intent of the Parties to this Agreement.
- n. This Agreement is made for the benefit of the Parties hereto and is not intended to confer any benefit upon any third party.
- o. District and Applicant agree that neither will hold District's engineer responsible for alleged engineering defects in the above-described Facilities unless such claim results from such engineer's failure as District's consultant to exercise the judgment and care, under circumstances then prevailing, which duly licensed civil engineers of prudence, skill, discretion and intelligence would exercise in (1) the review and approval of the plans and specifications for the design and construction of the subject facilities or (2) any review or supervision of construction necessary to protect the District's interests in insuring the adequacy and integrity of the new facilities.

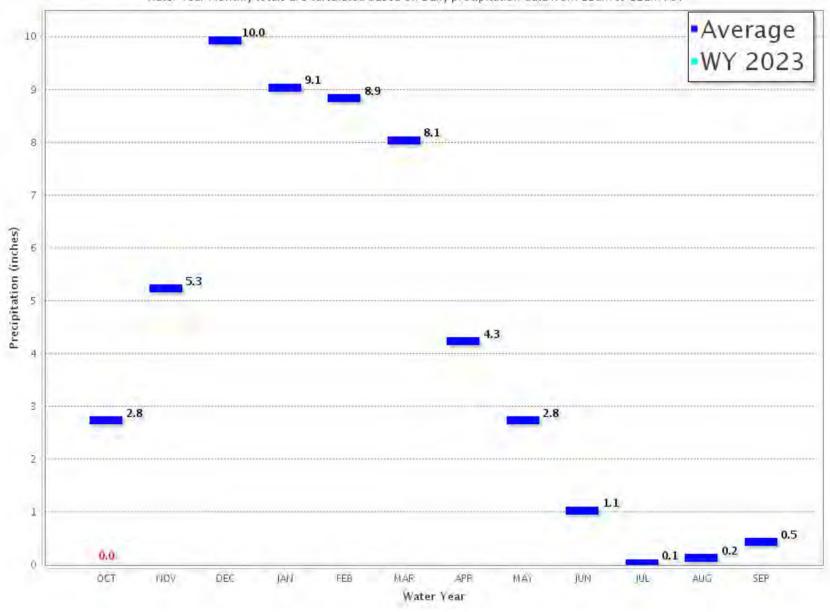

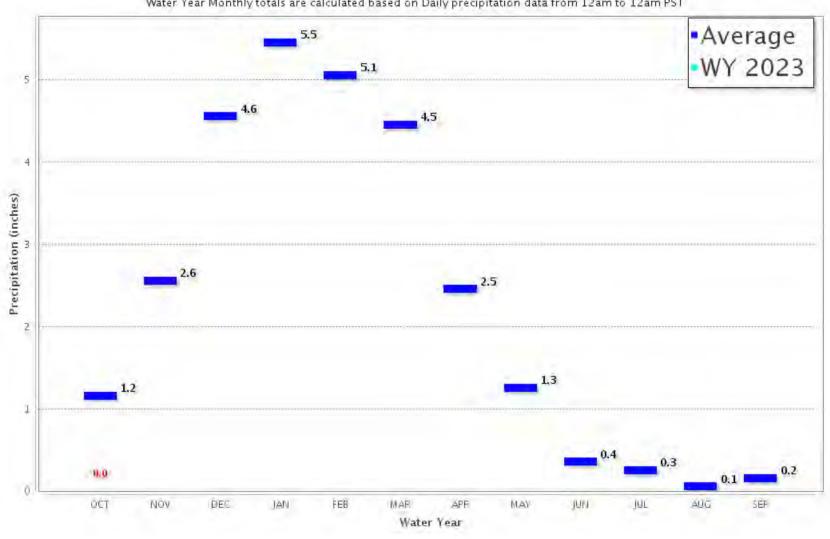


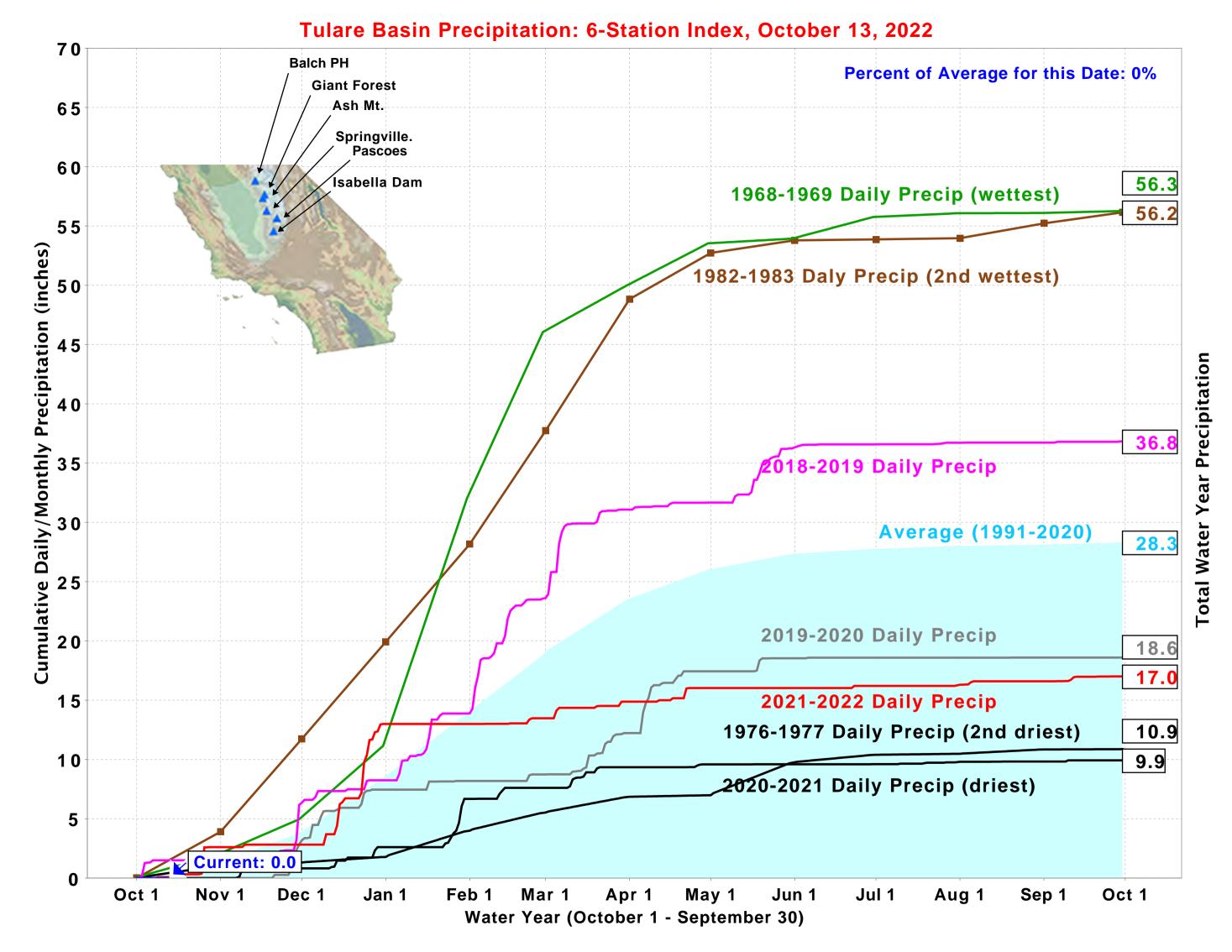
Tulare Basin 6-Station

Precipitation Index for Water Year 2023 - Updated on October 13, 2022 01:48 PM

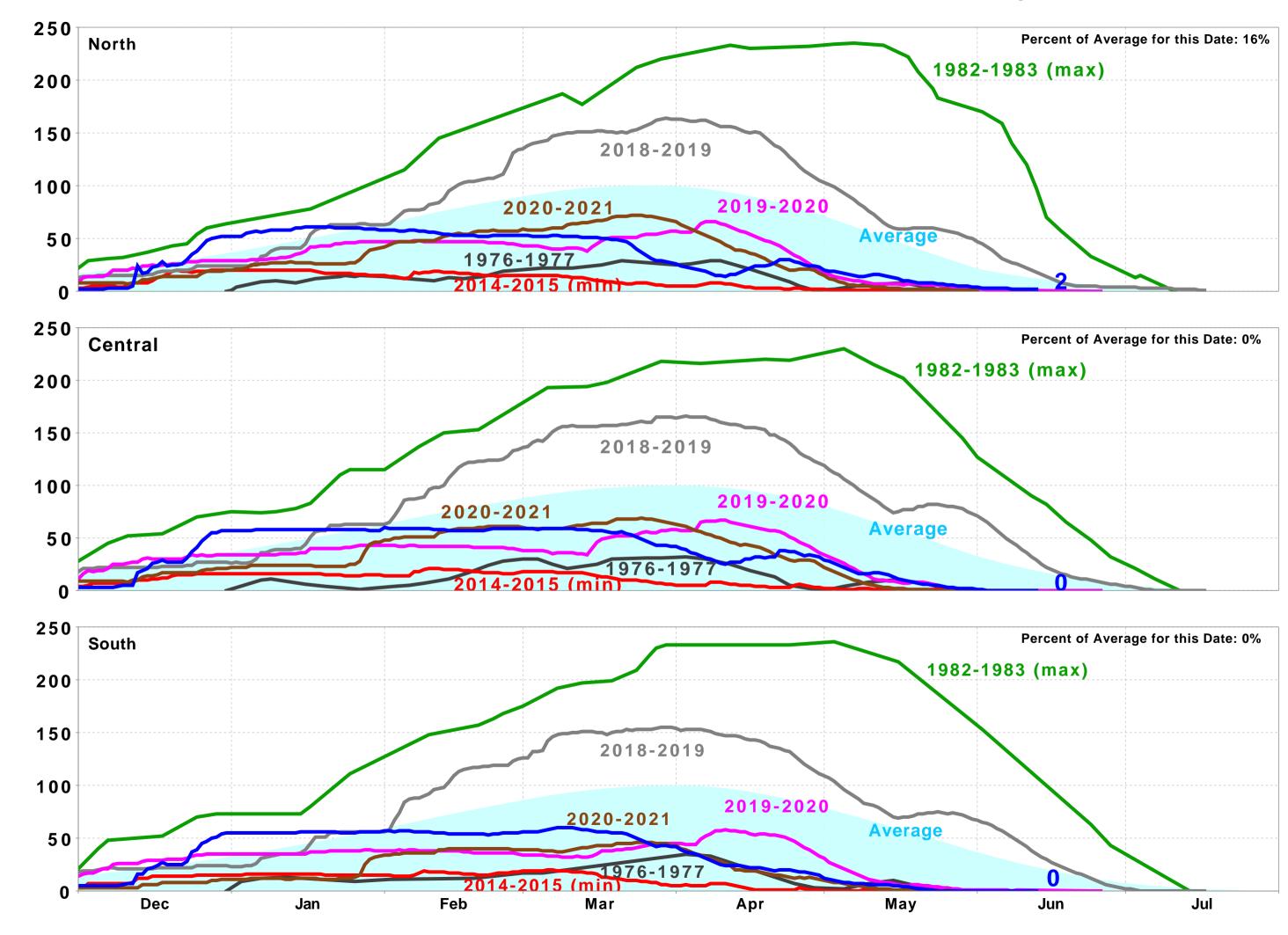

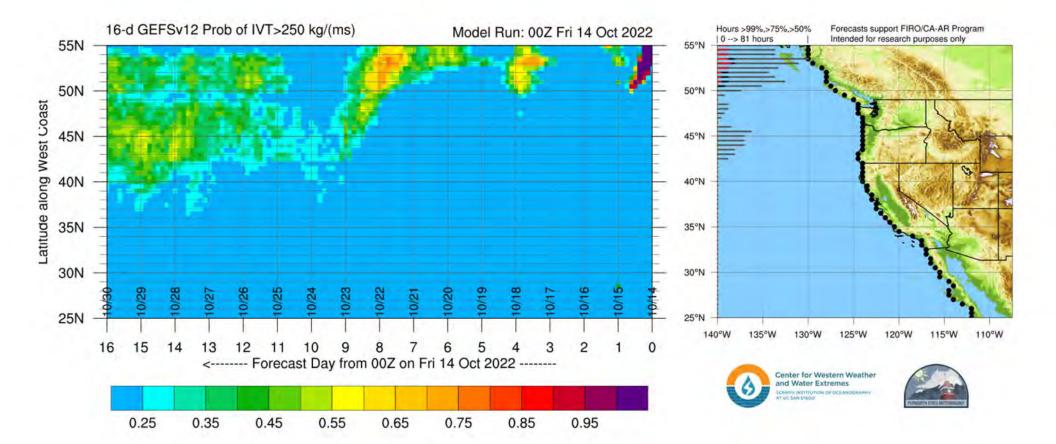

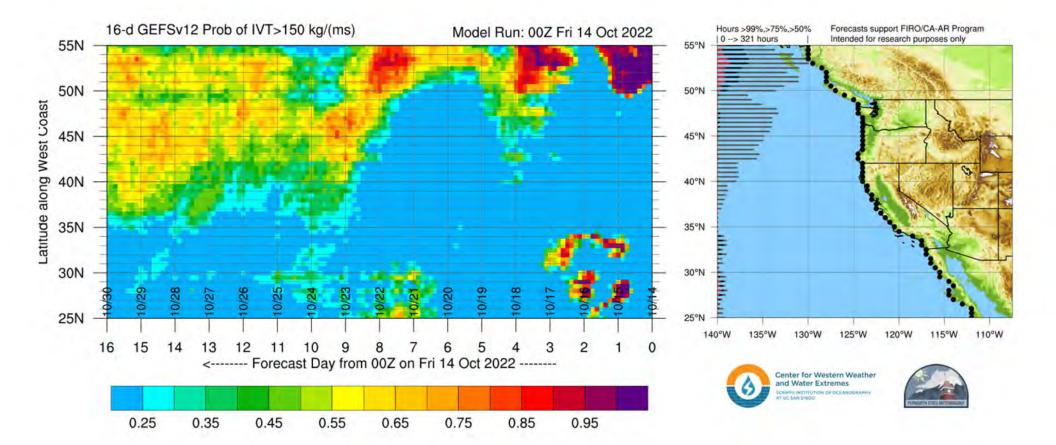

RE: Report of Recent Activities

This is the October 11, 2022, Kern River Watermaster Report. Art Chianello, City of Bakersfield, retired the end of September. We wish him well and look forward to seeing him occasionally. At this point, I am communicating with Daniel Maldonado at the City.

Isabella Dam Safety Modification Project – The COE October 2022 Situation Report is attached for your review and information. Completions times include:

- Labyrinth Weir, 98% completion, November (no change)
- Main Dam, 91% completion, upstream protection continuing, November (slipped a month)
- Service Spillway, 88.5% completion, final excavation November
- Emergency Spillway, 98% completion, final excavation end of October
- Auxiliary Dam, 95.5% completion, November (no change)

The Kern River Group did not meet with representatives from the COE during September. The next meeting with the COE is scheduled for 8:00 am, December 7, 2022.

Runoff and Operations – Late summer and early fall temperatures have continued to be warmer than usual. Inflow into Isabella is at or below 100 cfs. Attached is the October 10, 2022, Tulare Basin Precipitation 6-Station Index. The Index started a new water year as of October 1st and sits at 0.0 inches of precipitation and 0% percent of average. The COE B120 Forecast will begin in February 2023. We are all hoping for a wetter year! Also attached is a four-month Daily Lake Isabella Inflow Analysis (with actuals through October 10) that compares the last four months with the same period of other similar years.

Public Outreach – I was not contacted for any public inquiries during September. Lois Henry continues to release short videos regarding the Kern River and there will be a few more to follow. I encourage you to view the videos and they may be found on her website: SJVWATER.org.

Watermaster Records – City Central Records continue to maintain daily records of the Kern River. The 2021 Kern River Annual Watermaster Report was distributed in early September.

California Cooperative Snow Surveys – The 68th Annual Meeting of the California Cooperative Snow Surveys well be held November 2-4, 2022, at the Carmichael Elks Lodge in Carmichael, California. Registration is open for this Meeting. I will be attending on behalf of the Kern River Interests. Contact me if you are interested in attending the Snow Surveys Programs and I will provide you with the registration information. We expect to be invoiced by the first of November for this year's participation in the Snow Surveys.

Aerial Snow Observatory – The ASO collected the "Snow Off" data in the Kern River Basin on September 23, 24, and 30, 2022. The remaining flights will be scheduled between January 1, 2023, and April 1, 2023.

Location & Description

Isabella Lake Dam (consisting of a Main Dam, Auxiliary Dam and service spillway) is located about 40 miles northeast of Bakersfield in Kern County, California, and became fully operational in 1953. The Main Dam is located near the confluence of the north and south forks of the Kern River and the Auxiliary Dam is located about half a mile east of the Main Dam. The Main Dam is a 185-foot-high earth-fill dam, and the Auxiliary Dam is a 100-foot-high earth-fill dam. The service spillway is located between the two dams. The reservoir (Isabella Lake) has a gross storage capacity of 568,075 acre feet.

Advisory

- USACE are following the latest CDC guidelines to ensure the safety of our employees and our partners, and to take necessary precaution to prevent the spread of COVID-19.
- The Phase II Dams and Spillways contractor continues construction activities. As a result, the site including Engineers Point is an active construction area and is off limits to the public.
- Corps policy prohibits public operation of unmanned aircraft systems, such as drones, on or above federal lands and waters managed by USACE. The policy is intended to ensure critical infrastructure security and public safety.

Looking Ahead (Next 30+ days)

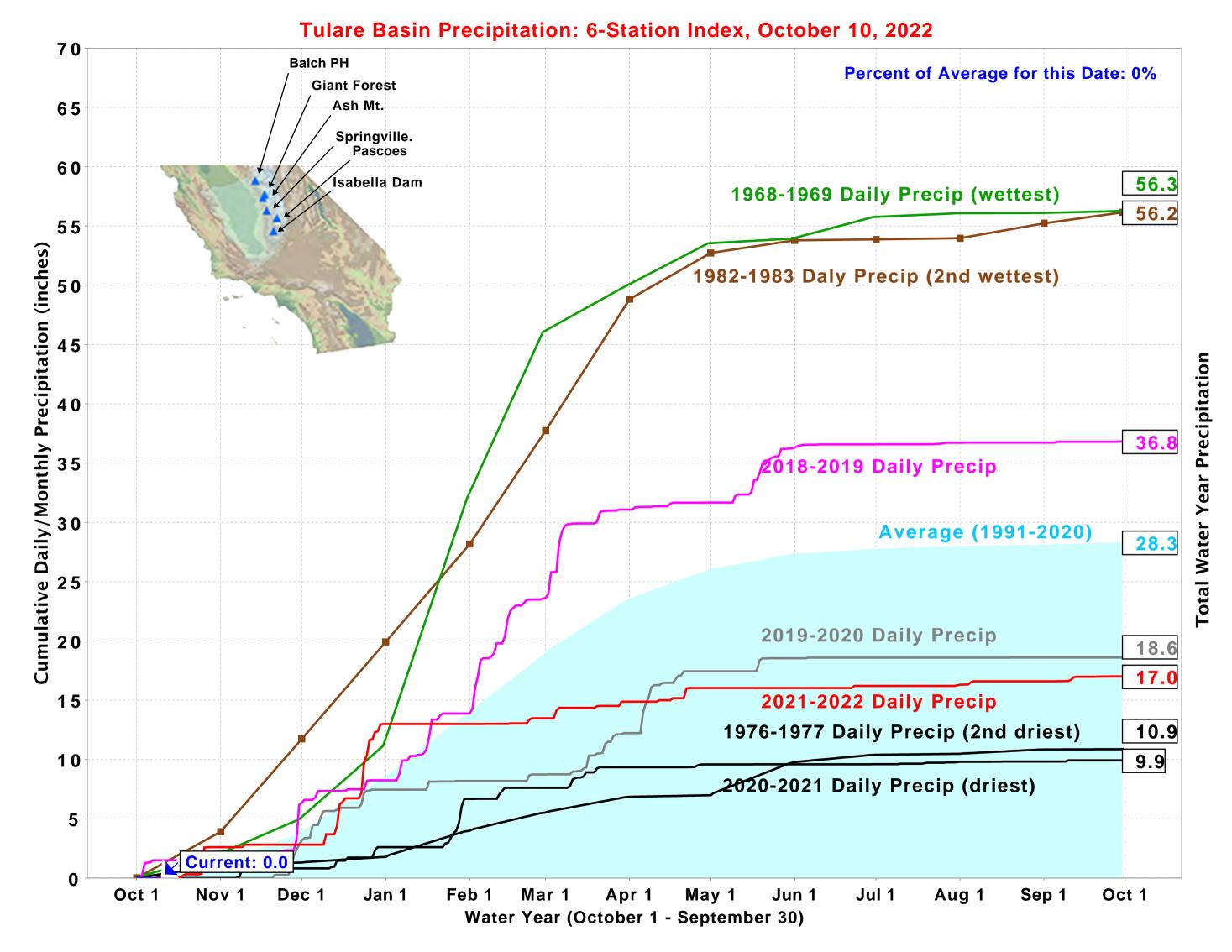
- Main Dam and Service Spillway work continues with 91.1% completion and 88.5% respectively.
 Contractor continues placing stone protection material on the upstream slope of the Main Dam. Service Spillway precision blast projected in October and final excavation in November 2022.
- Emergency Spillway total common and rock excavation is at 98% completion. Excavation anticipated complete by the end of this month.
- Labyrinth Weir at 98% complete. Construction of final wall sections began last week. Target completion is projected in November 2022.
- Auxiliary Dam is 95.5% complete overall. Anticipated scheduled completion in November 2022.
- In support of the USFS Visitor's Center project, USACE Sacramento District accepted the Offer to Sell for the former Bank of America property on 20 Sept 2022. The Sacramento District is working to close on the property sale as soon as possible. Design start under coordination.

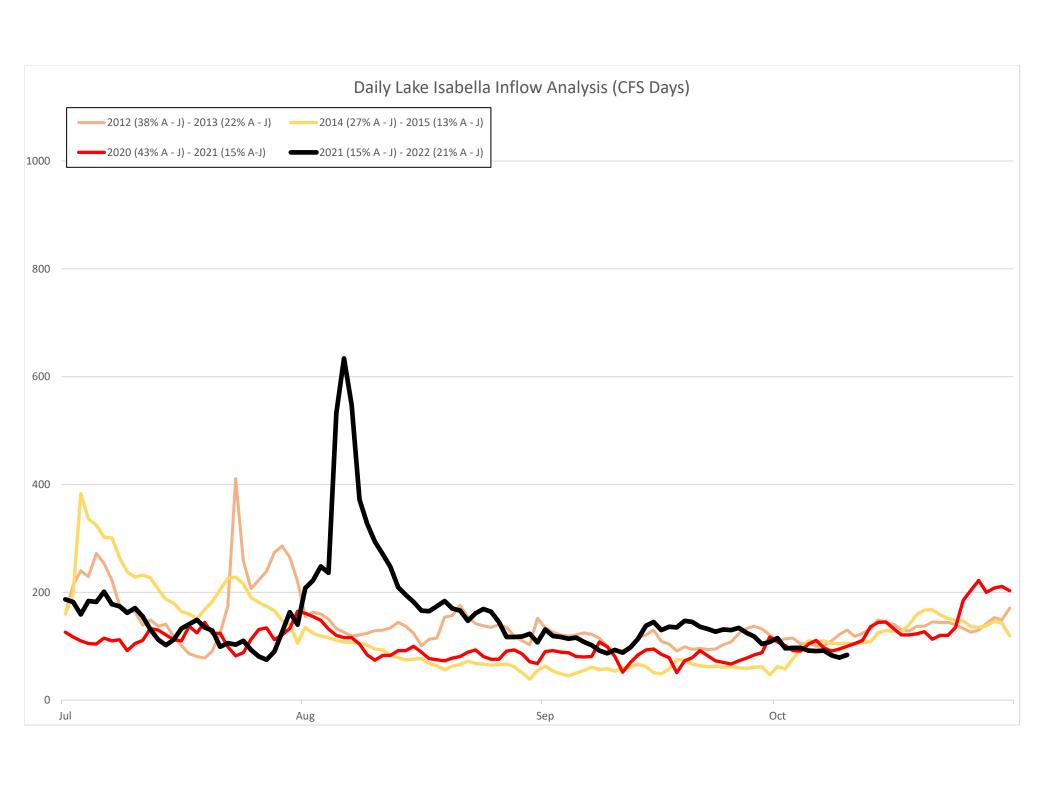
Current Lake Status (as of October 4, 2022)

The current pool resides at 39,079 acre-feet (elevation 2,536 feet-IPD), which is 11% of restricted pool and 22% of flood conservation pool.

As part of our interim risk reduction measures, Isabella Lake is restricted to 361,250 acre-feet (elevation 2,585.5 feet-IPD) outside of flood season. During flood season (~November-March), flood conservation pool is restricted to 170,000 acre-feet (elevation 2,560.4 feet-IPD). 1.0 SUMMARY

Kern Delta Water District serves Kern River and State water to approximately 90,000 irrigatable acres of land within its boundaries via five different service rights: Kern Island, Buena Vista, Stine, Farmers, and Eastside. In the 2021 growing season, 143,174 acres of land were cultivated (multiple cropping included) and approximately 11,175 acres of land being idle either due to crop rotation or conversion to permanent crops such as almonds.

The season's top produced commodity was wheat, with 29,909 acres being cropped, followed by almonds and corn, with 19,822 and 17,948 acres being cropped respectively. Table 1 shows selected crops and their accompanying growth trend.

2.0 CROPS

Approximately 89 crop varieties were grown throughout the District in 2021 (see **Appendix A** and **Appendix B** for individual crop types, locations, and acreages). The major produced commodities are discussed briefly in the following sections.

2.1 TREES

Almonds continue to be the top tree crop within the District, with 19,822 acres in production, followed by Pistachios at 12,196 acres in production. Table 2 below summarizes the tree crops grown within the District.

2.2 WHEAT

Wheat continues to be a major crop grown within the District, with approximately 29,909 acres being cropped.

2.3 CORN

Corn production increased by 928 acres in 2021, with 17,948 acres being cultivated, compared to 17,020 acres in 2020.

2.4 ALFALFA

Alfalfa cultivation within the District remained relatively steady, with 13,107 acres in production, a decrease of 310 acres from 2020.

2.5 VINES

Vine production includes table grapes, raisins, and wine grapes. Vine production remained relatively steady from 2020 through 2021, with 4,819 and 4,837 acres being cropped respectively.

3.0 ORGANICS

Approximately 2,621 acres of organic crops were grown within the District, with potatoes being the top organic crop with 508 acres in production.

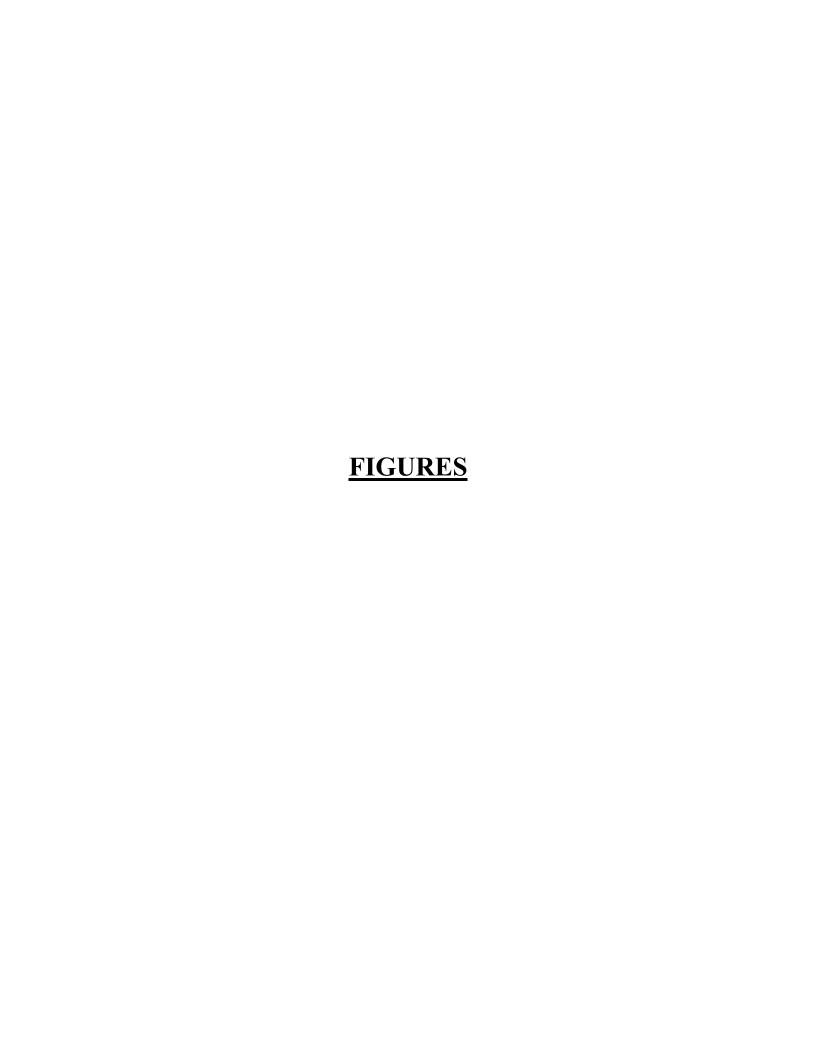

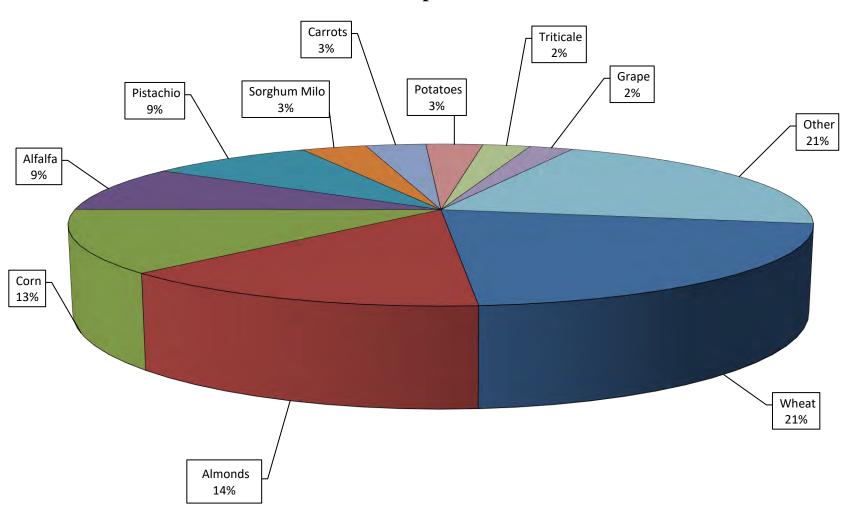
4.0 CONCLUSION

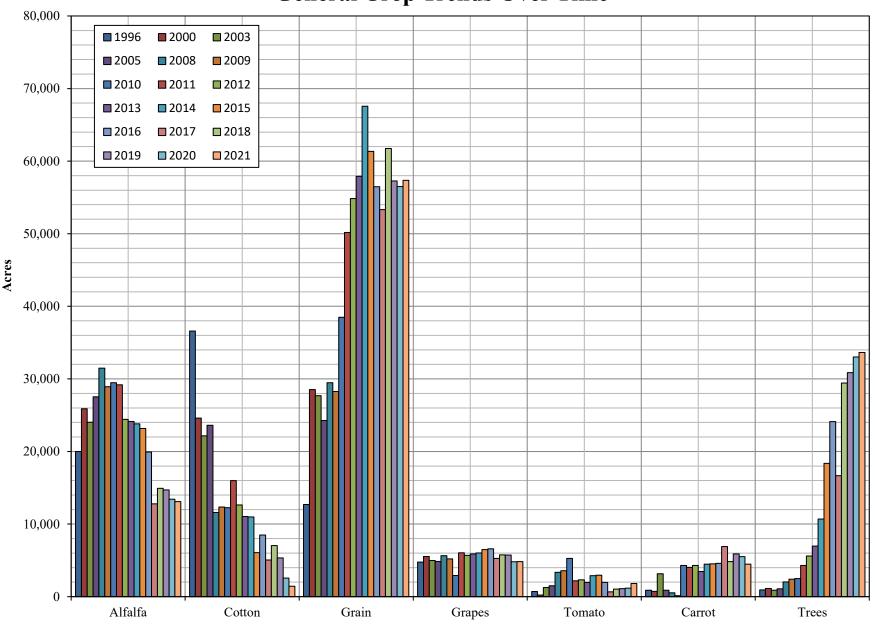

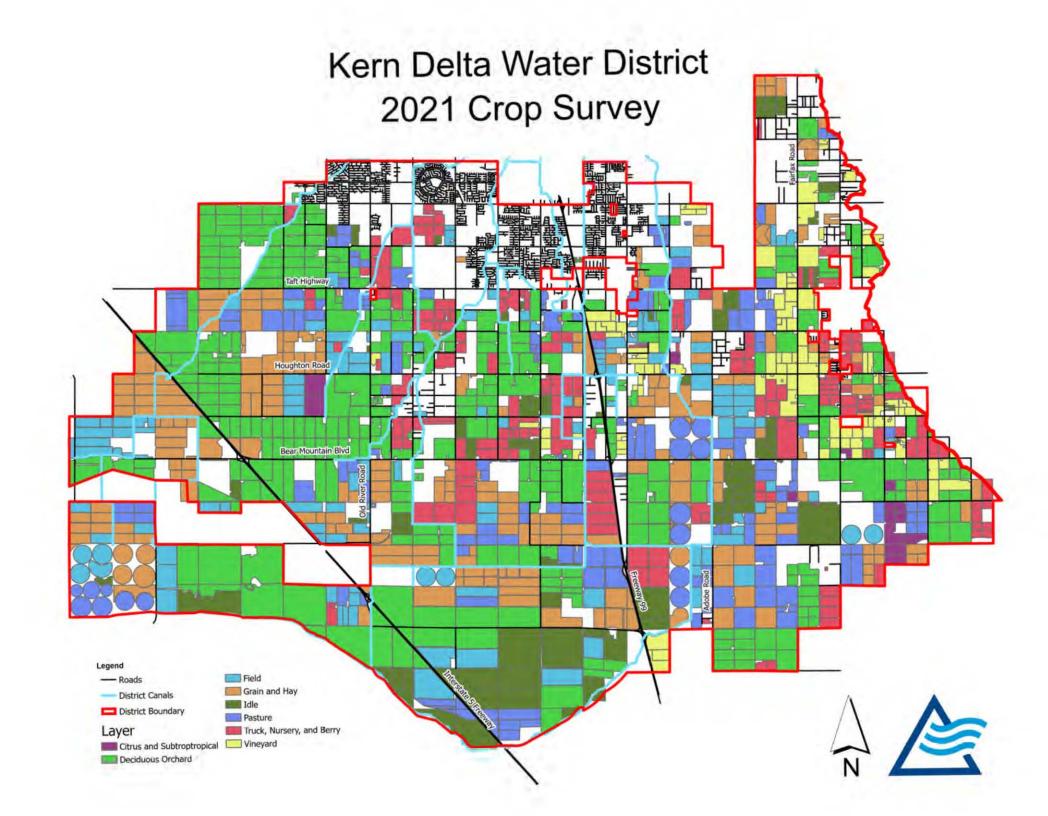


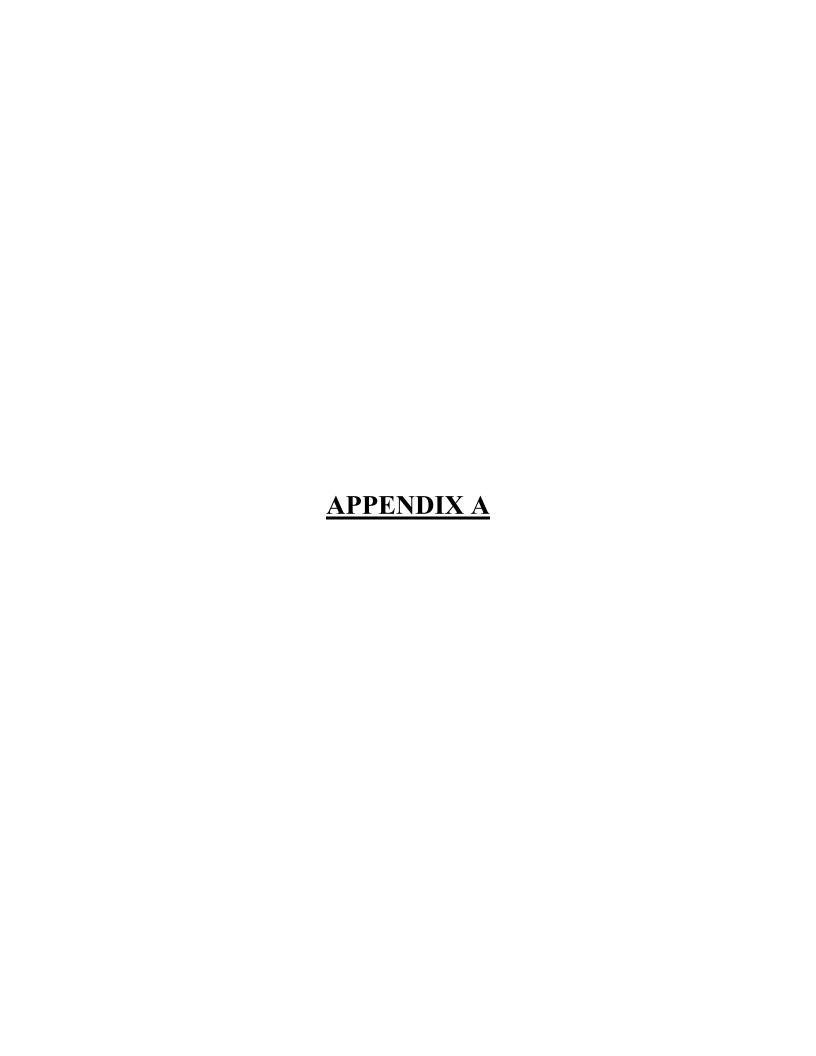
Kern Delta Water District 2021 Crop Production

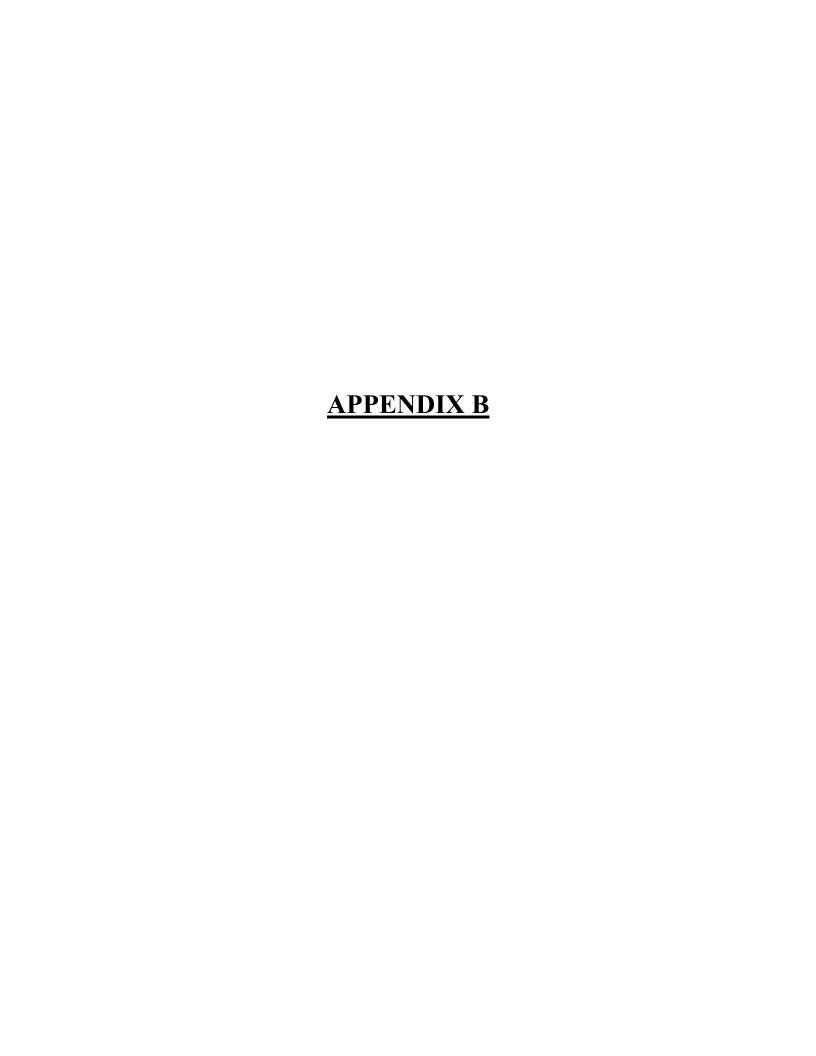

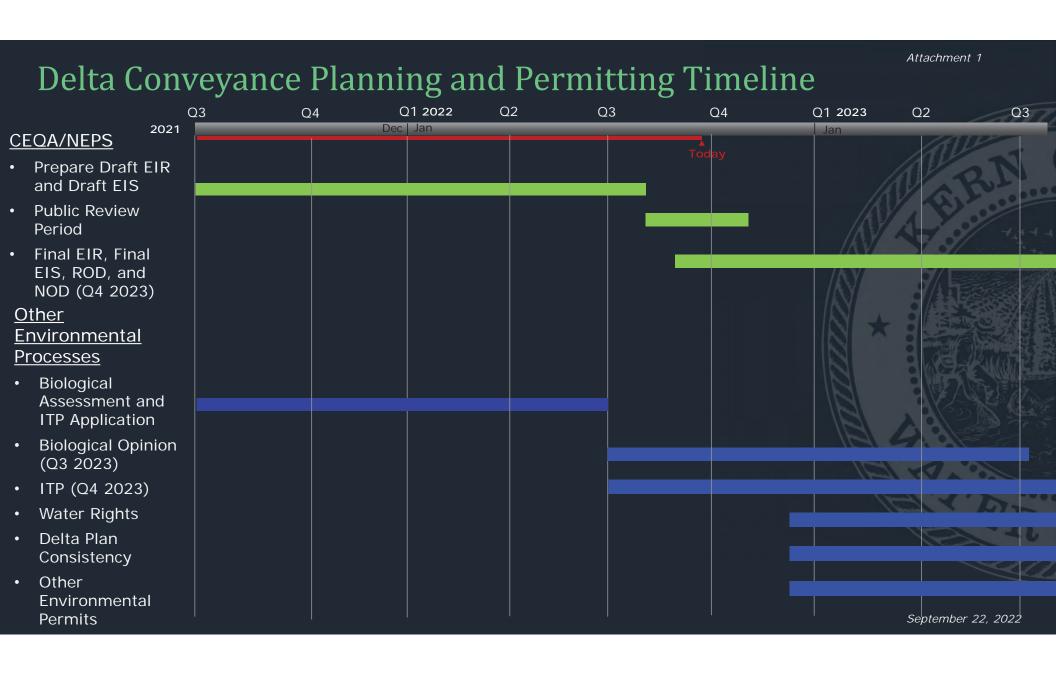

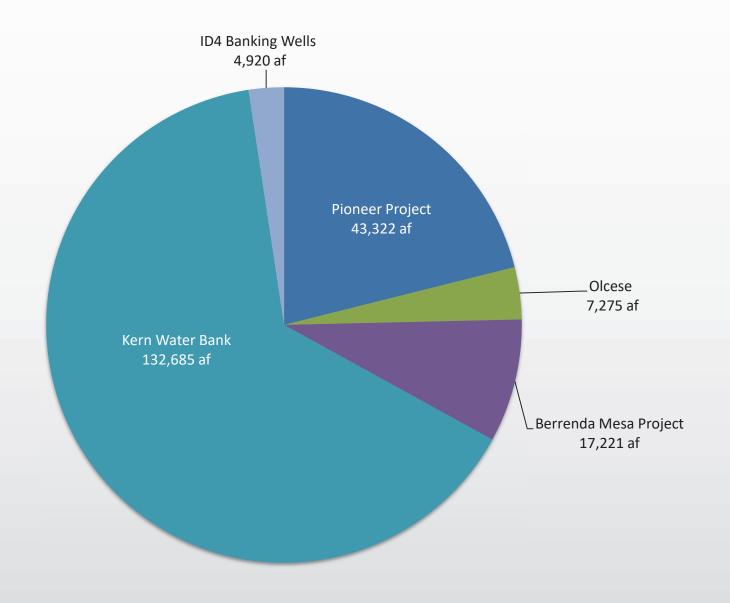

• MET has further notified the District that they intend to call for the return of regulated water in 2023 as well. District staff is planning for this request.

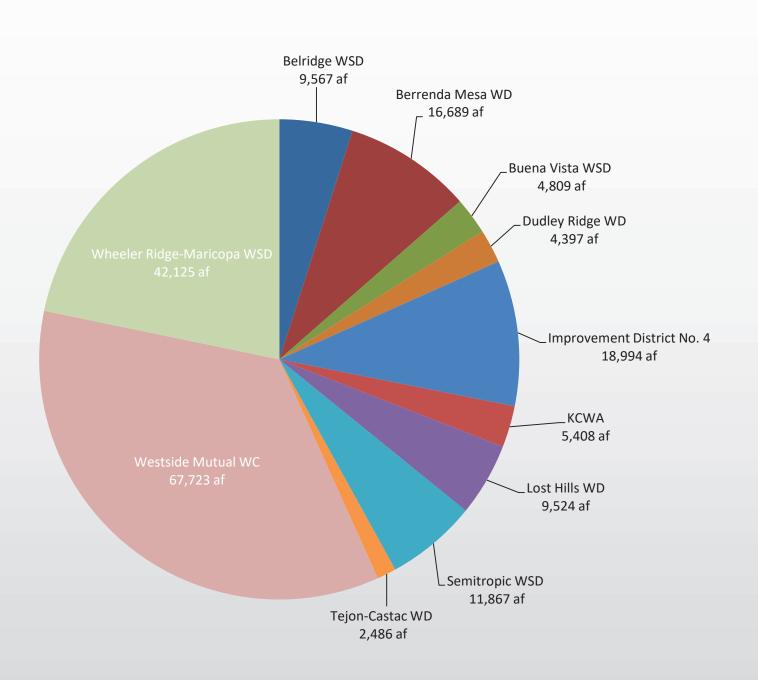

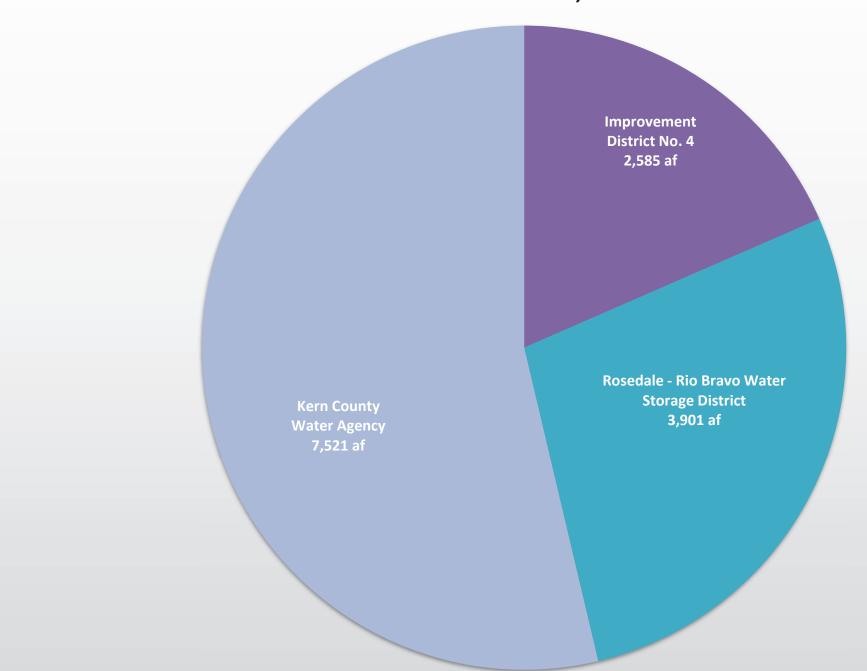
Kern Fan Banking Projects 2022 Estimated Gross Recovery by Project Through August 31, 2022



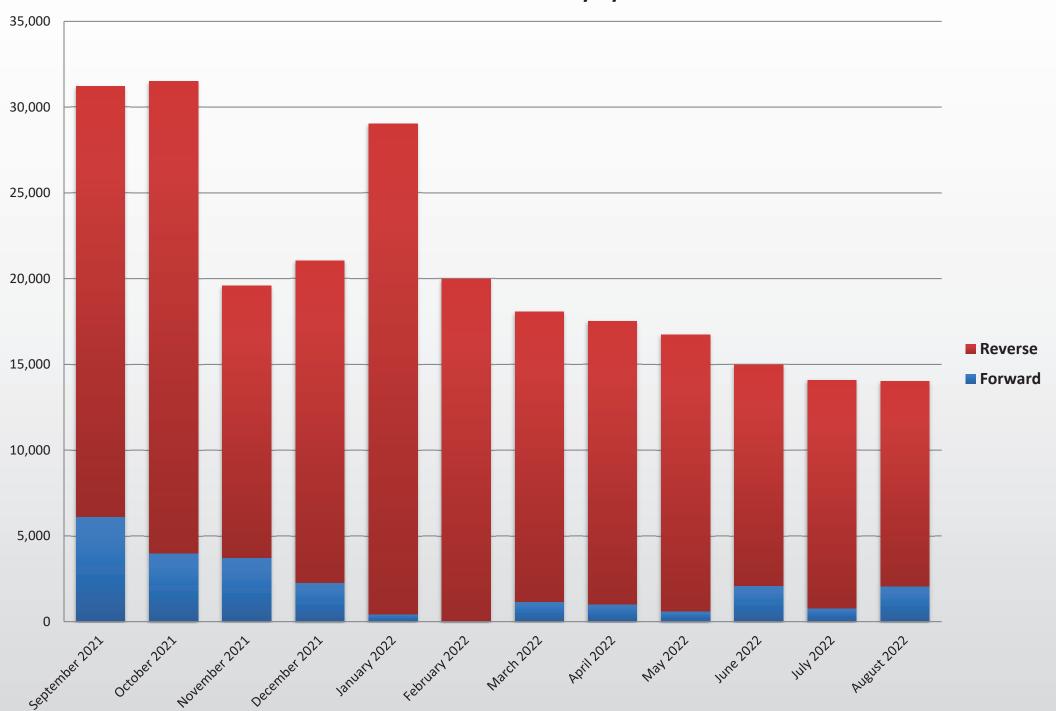
Kern Fan Banking Projects 2022 Estimated Recovery by Participant Through August 31, 2022



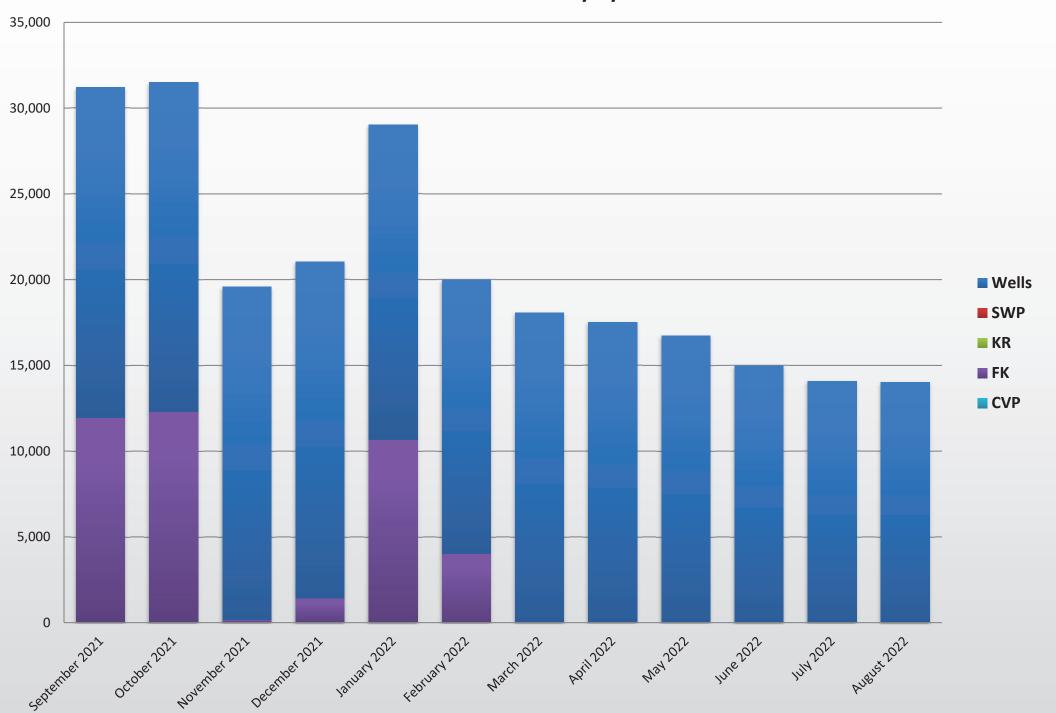

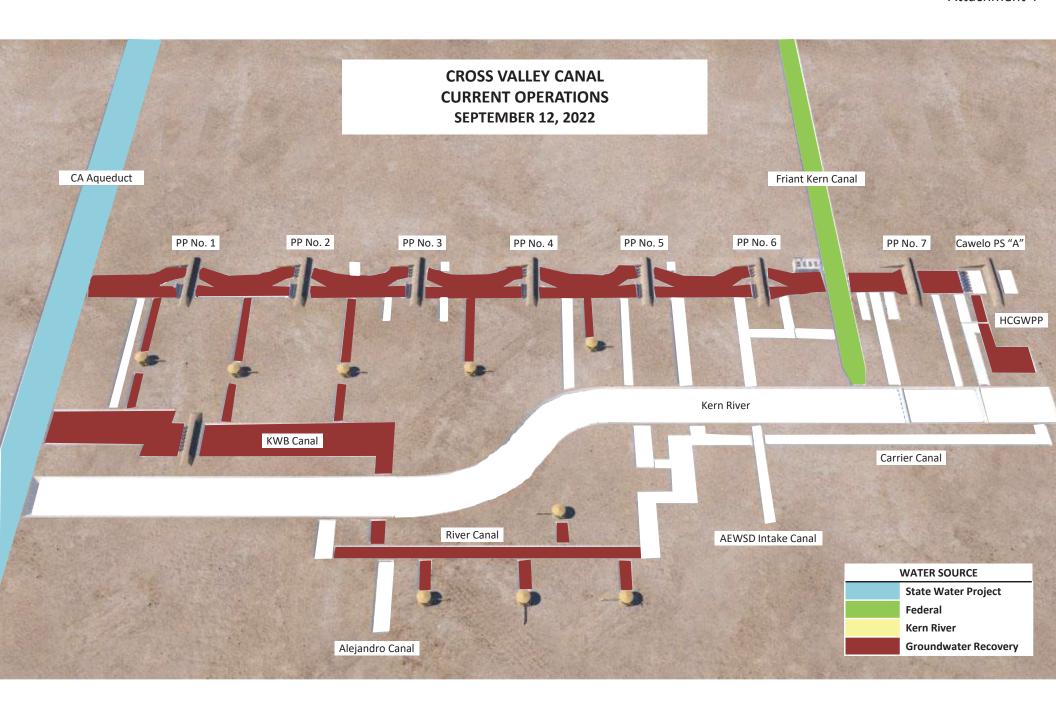


Cross Valley Canal Twelve Month Delivery by Direction
