President Palla called to order the Regular Session of the Kern Delta Board of Directors at 1:40PM.

II. CONSENT CALENDAR

M/S/C (Mendonca/Tillema) (yes-9, no-0): By unanimous vote the Board approved and authorized items II A through II C of the Consent Calendar.

- C. Approval of the February/March District Disbursements.

III. BUSINESS AND FINANCE

- A. <u>Business & Finance Committee Report(s) March 16, 2023:</u> District Controller Duncan provided a report from the March Business & Finance Committee Meeting.
- A(i). <u>Approval of February 2023 Financial Reports:</u> Mr. Duncan presented the February 2023 District and Water Banking Project(s) Financial Statements, Treasurer's Reports, and District Delinquency Report.
- M/S/C (Antongiovanni/Garone (yes-9, no-0): By unanimous vote the Board approved the February 2023 District and Water Banking Project(s) Financial Statements, Treasurer's Reports, and Delinquency Report as presented.
- B. Approval of Resolution 2023-02 Setting District State Water Tolls (Recommended by the Business and Finance Committee): Staff presented information regarding the results of the annual calculations associated with the setting of the District State Water Tolls for 2023. Following the presentation, staff informed the Board that due to circumstances associated with the 2023 Water Year, utility and transfer water will be available throughout the District. Based on this, the Business and Finance Committee recommends the Board maintain the 2022 District State Water Tolls as is for 2023, with the understanding that District State Water Tolls will not be applied until a point in time when transfer water is no longer available, if at all.

M/S/C (Antongiovanni/Kaiser (yes-9, no-0): By unanimous vote, the Board approved maintaining the 2022 District State Water Tolls for 2023, with the understanding that such tolls will not be applied until a point in time when transfer water is no longer available, if at all.

IV. OPERATIONS AND PROJECTS

A. - A(i-iv). Operations and Projects Committee – March 7, 2023: Assistant General Manager Bellue briefly reported on several items. Mr. Bellue's update included District maintenance activities, recent encroachment permit requests, pending development projects impacting District facilities, and a status update related to the Old River and Sunset Groundwater Banking projects.

A(i)(a). Review and Approval of Encroachment Permit for Hathaway LLC on the Eastside Canal: Staff presented an encroachment permit to allow Hathaway LLC to access one of their properties off of the Eastside Canal south of E. Panama Lane.

M/S/C (Spitzer/Borba (yes-9, no-0): By unanimous vote, the Board approved an Encroachment Permit for Hathaway LLC on the Eastside Canal as presented.

V. WATER RESOURCES REPORT

- A. A(i-ii). <u>District Watermaster Report:</u> Staff reviewed and discussed the water supplies of the District for the month of February and early March. Approximately 12,500 acre-feet of water was diverted in District during February. Staff also provided information related to current precipitation totals and future forecasts. It was also noted that the SWP allocation increased to 35%. The April through July Kern River runoff forecast, as provided in the Department of Water Resources B120 report, is currently 351% (313% for the Water Year).
- B. B(i). <u>Kern River Watermaster Report</u>: The March Kern River Watermaster Report and Isabella construction update, provided by the Army Corps of Engineers, was included in the Board packet.
- C. <u>District Groundwater Manager Report:</u> Groundwater Manager Marquez provided graphical information regarding depth to groundwater at various monitoring locations throughout the District.

VI. MANAGER'S REPORT

- A. Mr. Teglia provided a brief verbal report regarding the upcoming WAKC Water Summit, which will be held March 24, 2023. In addition, Mr. Teglia informed the Board that the City of Bakersfield initiated discussions with the District regarding potential expansion of the Mill Creek Linear Park improvements on the Kern Island Canal as well as a project to place improved fencing along sections of the Eastside Canal. Teglia stated that the conversations were preliminary in nature and the City will be working on conceptual plans for the District to review. Teglia also provided a brief update regarding 2023 water management activities and concluded his comments by recommending the April 4th Board Meeting and Operations and Projects Committee Meeting be canceled due to a conflict with the Isabella Dam ribbon cutting ceremony.
- B. External Agency Report: Mr. Teglia provided verbal comments supplementing a memorandum included in the Board package which provided information on the meetings and activities of various external agencies. These agencies include, but are not limited to, the Kern County Water Agency (including the status of the Delta Conveyance Project and Contract Extension), Kern Fan Authority, Kern River Watershed Coalition Authority, Kern Groundwater Authority, Kern River Groundwater Sustainability Agency, the South Valley Water Resources Authority, the Water Association of Kern County, and the Integrated Regional Water Management Plan.
- C. <u>Water Banking Projects Report:</u> Mr. Teglia provided verbal comments supplementing a memorandum included in the Board package which provided information on water banking project activity on the Kern Fan. Mr. Teglia also conveyed that the District has ceased returning regulated water to MWD at the request of MWD.

VII. ATTORNEY'S REPORT

- A. <u>Form 700 Reminder:</u> District General Counsel Iger provided the Board with a reminder that annual form 700 reports were due April 1, 2023.
- B. B(i). Legislative Update: Mr. Iger provided the Board with a brief legislative update, including a

reference to the VAWC Legislative Update which was in the Board packet.



RECOMMENDATION:

Receive report, informational only.

DISCUSSION:

The Investment Policy of Kern Delta Water District requires the District's Treasurer to submit to the Board of Directors a quarterly investment report. In compliance with this directive the District Controller offers the following discussion and analysis of the District's cash and investments position and performance through the first quarter of the current year as of March 31, 2023.

A comparative overview of the District's investment portfolio as of March 31, 2023, is shown in the following table:

The position held at JP Morgan Funds is new to the District since the previous quarterly review dated January 12, 2023. The funds held at JP Morgan are in money market accounts that are 100% invested in US Treasuries earning 4.31% annually as of this memo. Interest earned on this investment totaled \$55,860 for the first quarter of 2023.

US Treasuries in the amount of \$2,000,000 matured in January 2023 and paid interest as expected in the amount of \$17,055 at maturity. The \$2,000,000 made available at maturity of the T-Bills was moved to the JP Morgan Money Market account at the direction of the Board. By the end of April 2023, an additional \$3,000,000 in T-Bills will mature and will be available for investment at the pleasure of the Board of Directors.

Yields on cash reserves held at the Kern County Treasury (KCT) have improved. As of December 31, 2022, annualized yield on KCT funds was 2.156% compared to 1.059% as of September 30, 2022. The attached "US Treasury Investment Summary" and "Kern County Treasurer's Pooled Cash Portfolio Summary" describe the nature and mix of the investments held at LPL Financial and at the KCT, respectively, as of March 31, 2023.

As of March 31, 2023, Fair Market Value of KCT funds had improved to 96.25% of Cost compared to 95.99% of Cost as of December 31, 2022. The FMV of U.S. Treasuries and Federal Agencies, representing 76.10% of the entire KCT portfolio, is 95.82% and is a key factor in the overall valuation of the portfolio. As a reminder, the FMV adjustment is a valuation disclosure required by generally accepted accounting principles and does not reflect the purchasing power of the investment. If all invested cash was liquidated from the District's accounts at Kern County, the actual cost, plus accrued interest, would be recovered and not the fair market value.

It should be noted that (1) all investment actions executed since the last report have been made in full compliance with the investment policy of the District and, (2) the District will meet its expenditure obligations for the next six months.








Re: Annual Cost of Living Adjustment Review.

Background:

Typically, each April the Board has considered annual cost of living adjustments (COLA) for District employees ranging from 0-2%. In addition, the annual discussion has also included potential merit raises ranging from 0-2%. Once approved by the Board these compensation adjustments become effective the first pay period which includes May 1st.

In 2020, staff developed a new District Salary Schedule which was designed to provide greater clarity and structure to the compensation for each employee position classification. In addition, the schedule articulates how employees can achieve merit increases based on both time and performance. On April 21, 2020, the Board approved the new salary schedule which included a 2% COLA.

Given the previous actions of the Board, the annual process is now focused on the appropriateness of authorizing a potential COLA based on a review of several annual CPIs traditionally considered by the Board. Any COLA authorized by the Board will be reflected in a corresponding adjustment to the attached salary schedule.

Recommendation:

Considering the average increase of the above CPIs, staff and the Business and Finance Committee are recommending the Board consider approving a COLA of 3.5% which will become effective the first pay period including May 1, 2023. This adjustment will be provided to all employees covered by the salary schedule and is reflected in the proposed revised salary schedule attached. Adequate funds are available in the approved 2023 Budget to cover the costs of the recommended COLA which is estimated to be \$62,671.




CURRENT RESERVOIR CONDITIONS




Isabella Lake **Conditions**






Northern Sierra 8-Station




Tulare Basin 6-Station




California Snow Water Content, April 14, 2023, Percent of April 1 Average

Above average precipitation from late February to date continues to contribute inflows into State Water Project (SWP) reservoirs and increase the snowpack in the Sierras. Therefore, the Department of Water Resources (DWR) is increasing the State Water Project (SWP) allocation from 35 to 75 percent of most¹ SWP contractors' Maximum Annual Table A amounts.

In determining available SWP supplies, DWR has considered several factors including SWP contractors' projected 2023 demands, existing storage in SWP conservation facilities, estimates of future runoff, SWP operational and regulatory requirements from the federal Endangered Species Act and California Endangered Species Act, and water rights obligations under the State Water Resources Control Board's authority. DWR may revise the SWP allocation if warranted depending on the rest of the year's hydrologic conditions and available SWP water supplies.

DWR will develop the 75 percent water delivery schedules by prorating the existing schedules submitted by the Contractors in October 2022 (as part of initial requests), including any subsequent updates that may have been provided to DWR. If a contractor foresees any changes to their water delivery schedule, please communicate such changes to DWR in a timely manner.

With the 2023 SWP allocation above 40 percent, according to the "Draft Guidelines for State Water Project Allocation for Human Health and Safety Need Pursuant to








6-10 Day Temperature Outlook









8-14 Day Precipitation Outlook

RE: Report of Recent Activities

This is the April 10, 2023, Kern River Watermaster Report.

Isabella Dam Safety Modification Project – The COE April 2023 will be distributed to the group when I receive it from the COE.



The Kern River Group is meeting with the COE on a weekly basis to receive an update on the Project, Reservoir conditions, and Fill Plan. The Deviation Plan to exceed the 360,000 AF restriction was approved in late March by General Gant. The Ribbon Cutting is scheduled for April 4, 2023.

Many of us attended the April 4th Ribbon Cutting ceremony. Although it was a cold and windy day, it was a great event. I took the opportunity to take this photo of three old Kern River guys: Dana Munn, Mark Mulkay, and Art Chianello.

Runoff and Operations – Runoff during late March and early April fell off and allowed significantly. Isabella peaked very close to 368,000 AF but has been pulled down to less than 307,000 AF due to the activities of the Kern River Interests. This year's snow melt is just now beginning, and inflow will continue to climb over the next several weeks. The COE has "requested" an outflow from Isabella of 5400 cfs and I expect them to request higher flows in the next week or so. Attached is the April 10, 2023, Tulare Basin Precipitation 6-Station Index for water year 2023. The Index is at 50.6 inches of precipitation, 208% percent of average for this date compared to the water year and continuing to rise. Also attached is the April 10th Tulare Basin 6-Station Precipitation Bar Chart showing the same information in a monthly format. You will notice that March precipitation was 17.1 inches – way above the average of 4.5 inches. The California Snow Water Content (copy attached) shows the southern Sierra at 307% of the April 1st average. These numbers are changing rapidly and may well be out of date by the end of this week.

Public Outreach –I continue to field calls and emails from individuals and news outlets (including the LA Times and Washington Post) regarding the above average precipitation, flooding, reservoir outflows, and the COE's Fill Plan.

California Cooperative Snow Surveys – Due to heavy storm activity, our first on the ground snow surveys were done at the end of March. This data will be included in the next DWR B-120 update, and it

was also sent to the ASO for their modeling. The most recent DWR B-120 update (March 28) predicts (at the 50 Percentile) 422% of normal runoff and 1.8 million AF during April through July.

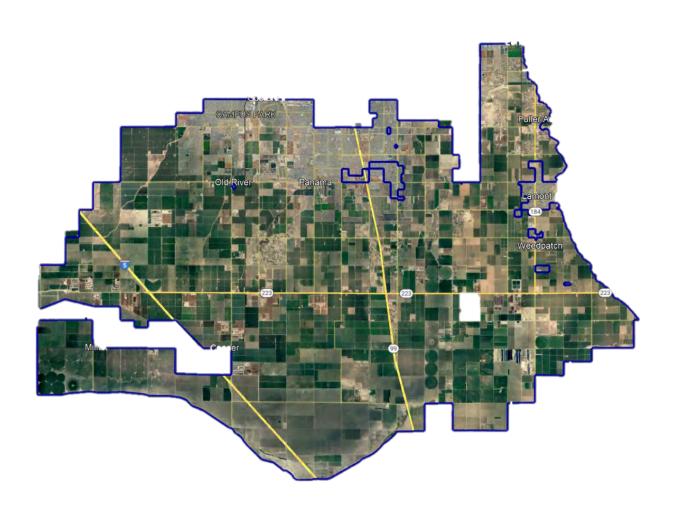
Aerial Snow Observatory – The ASO continues to hold weekly meetings to discuss the schedule of flights, collection of data, and reporting. Due to heavy storm activity, our first ariel survey was flown at the end of March and the next flights are scheduled for approximately May 1st and June 1st.

ILRP stakeholders,

On 27/28 April 2023, Irrigated Lands Regulatory Program (ILRP) staff will be providing an informational update to the Central Valley Water Board on progress toward the development of Groundwater Protection Targets. The purpose of the development effort is to establish township-level nitrogen loading rates from irrigated agricultural operations that are estimated to achieve compliance with Receiving Water Limitations for groundwater within the time schedules specified in applicable ILRP Waste Discharge Requirements. Once approved, the Targets will be incorporated into existing Groundwater Quality Management Plans throughout the region.

The informational item will be presented during the Central Valley Water Board's regularly scheduled meeting, which will be held in the Kern County Board of Supervisors Chambers, located at 1115 Truxtun Ave, Bakersfield, CA 93301. Under the federal <u>Clean Water Act (CWA)</u> and the state's pioneering <u>Porter-Cologne Water Quality Control Act</u>, the State and Regional Water Boards have regulatory responsibility for protecting the water quality of nearly 1.6 million acres of lakes, 1.3 million acres of bays and estuaries, 211,000 miles of rivers and streams, and about 1,100 miles of exquisite California coastline.





Summary: The California Environmental Quality Act (CEQA) authorizes a state agency or a local agency that determines that a project is not subject to CEQA to file a notice of exemption with the office or the county clerk of each county in which the project will be located, as provided. CEQA requires the county clerk to make the notice available for public inspection and post the notice within 24 hours of receipt in the office or on the internet website of the county clerk, as specified. If a person has made a written request to a public agency for a copy of a notice of determination or notice of exemption for a project before the date on which the public agency approves or determines to carry out the project, CEQA requires the public agency, no later than 5 days from the date of the public agency's action, to deposit a copy of the written notice addressed to that person in the United States mail, first-class postage prepaid. CEQA provides that the date upon which the notice is mailed does not affect the limitations periods applicable to specified actions or proceedings to attack, review, set aside, void, or annul specified acts or decisions of a public agency on the grounds of noncompliance with CEQA. The bill would require the county clerk to post the notice both in the office and on the internet website of the county clerk within 24 hours of receipt. The bill would require a public agency to provide both the notice and any subsequent amended, corrected, or revised notice, as specified, in response to a written request for the notice, regardless of the delivery method. The bill would toll, except as provided, the limitations periods applicable to specified actions or proceedings to attack, review, set aside, void, or annul specified acts or decisions of a public agency until the date on which the public agency deposits in the mail or sends by email to the requestor a copy of the notice, including any subsequent amended, corrected, or revised notice, or the date on which the public agency submits the notice to a specified state entity, as described.

Summary: The Sustainable Groundwater Management Act authorizes the State Water Resources Control Board to designate specified basins as probationary basins if certain conditions are met, including, but not limited to, that the department, in consultation with the board, determines that a groundwater sustainability plan is inadequate or that the groundwater sustainability program is not being implemented in a manner that will likely achieve the sustainability goal. Current law requires the board, if it designates a basin as a probationary basin pursuant to specified conditions, to identify the specific deficiencies and potential remedies. Current law authorizes the board to request the department, within 90 days of the designation, to provide technical recommendations to local agencies to remedy the deficiencies and to develop an interim plan for the probationary basin one year after the designation, as specified. This bill would delete the authorizations for the board to request technical recommendations from the department and to develop an interim plan as described above. The bill would instead require the board to grant an 18-month grace period before the probationary basin designation becomes effective and would place various requirements on the board in working with a groundwater sustainability agency, including, among other things, requiring the board to provide clear benchmarks and guidance for groundwater sustainability agencies to improve their groundwater management plans.

Summary: Current law, until January 1, 2024, authorizes the legislative body of a local agency to use alternate teleconferencing provisions during a proclaimed state of emergency or in other situations related to public health that exempt a legislative body from the general requirements (emergency provisions) and impose different requirements for notice, agenda, and public participation, as prescribed. The emergency provisions specify that they do not require a legislative body to provide a physical location from which the public may attend or comment. Current law, until January 1, 2026, authorizes the legislative body of a local agency to use alternative teleconferencing in certain circumstances related to the particular member if at least a quorum of its members participate from a singular physical location that is open to the public and situated within the agency's jurisdiction and other requirements are met, including restrictions on remote participation by a member of the legislative body. These circumstances include if a member shows "just cause," including for a childcare or caregiving need of a relative that requires the member to participate remotely. This bill would authorize certain legislative bodies to use alternate teleconferencing provisions similar to the emergency provisions indefinitely and without regard to a state of emergency. The bill would also require a legislative body to provide a record of attendance on its internet website within 7 days after a teleconference meeting, as specified. The bill would define "legislative body" for this purpose to mean a board, commission, or advisory body of a multijurisdictional cross county agency, the membership of which board, commission, or advisory body is appointed and which board, commission, or advisory body is otherwise subject to the act. The bill would also define "multijurisdictional" to mean a legislative body that includes representatives from more than one county, city, city and county, special district, or a joint powers entity.
